4	(1) This rule is authorized by:
5	(a) Utah Constitution <u>Article X, Section 3</u> , which vests general control and

7	(b) Subsection <u>53E-3-401(4)</u> , which allows the Board to make rules to execute
8	the Board's duties and responsibilities under the Utah Constitution and state law.
9	(2) The purpose of this rule is to provide definitions that are used in the Board
10	rules beginning with R277.

12	R277-100-2. Definitions.
13	(1) "Accreditation" means the formal process for internal and external review and
14	approval under the standards of an accrediting entity adopted by the Board.
15	(2) "Agency" means:
16	(a) an entity governed by the Board;
17	(b) an LEA; or
18	(c) a grant sub-recipient.
19	(3) "Board" means the State Board of Education.
20	(4) "Charter school" means a school established as a charter school by a charter
21	school authorizer under <u>Title 53G, Chapter 5</u> , Charter Schools, and Board rule.
22	(5) "Comprehensive dropout intervention and prevention program" means a
23	program that:
24	(a) addresses needs of students who are not succeeding in a traditional school
25	environment;
26	(b) provides targeted instruction that increases student credit-earning rates
27	toward graduation; and
28	(c) partners with community entities to provide a continuum of services with the
29	focus of preparing students for life after high school.

30	(6)(a) "Cumulative file" or "cumulative folder" means a physical or digital record
31	maintained by an LEA for each student containing, at a minimum, the following

35	(iii) name and contact information for the student's parents;

49	board elected under <u>Title 20A, Chapter 14</u> , Nomination and Election of State and Local
50	School Boards.
51	(8) "Dual enrollment student" means a student who:
52	(a) is enrolled simultaneously in:
53	(i) a private school or home school; and
54	(ii) a public school; and
55	(b) is counted by an LEA in membership for purposes of generating state or
56	federal funding for only those courses or subjects for which the LEA provides
57	instruction.

(14) "Individualized education program" or "IEP" means a written statement for a 82 83 student with a disability that is developed, reviewed, and revised in accordance with 84 Part B of the Individuals with Disabilities Education Act (IDEA), <u>20 U.S.C. Section 1400</u> 85 (2004), and rule.

86	(15) "Individuals with Disabilities Education Act" or "IDEA," <u>20 U.S.C. Section</u>
87	1400 et seq. (2004), is a four part (A-D) piece of federal legislation that ensures a
88	student with a disability is provided with a Free Appropriate Public Education (FAPE)
89	that is tailored to the student's individual needs.
90	(16)(a) "Internal audit" means an independent appraisal activity established
91	within an agency as a control system to examine and objectively evaluate the adequacy
92	and effectiveness of other internal control systems within the agency <u>or the public</u>
93	education system.
94	(b) An "internal audit" is conducted in accordance with the current:
95	(i) International Standards for the Professional Practice of Internal Auditing; or
96	(ii) Government Auditing Standards, issued by the Comptroller General of the
97	United States.
98	(17)(a) "LEA" or "local education agency" means a school district or charter
99	school.
100	(b) For purposes of certain rules, "LEA" or "local education agency" may include
101	the Utah Schools for the Deaf and the Blind (USDB) if indicated in the specific rule.
102	(18)(a) "LEA governing board" means:
103	(i) for a school district, a local school board; and
104	(ii) for a charter school, a charter school governing board.
105	(b) For purposes of certain rules, "LEA governing board" may include the State
106	Board of Education as the governing board for the Utah Schools for the Deaf and the
107	Blind if indicated in the specific rule.
108	(19)(a) "Monitor" [ <del>or "oversee"</del> ]means to formally supervise, inspect, or examine
109	the compliance, performance, or finances of a program <u>or other set of requirements</u> .
110	(b) A monitoring [ <del>or oversight ]</del> program may include:

111	(i) review of financial and performance reports required of the subject program;

120	emotional, physical, and behavioral needs of a student or group of students; and
121	(ii) create individualized strategies and interventions to address identified needs.
122	(b) An LEA's multidisciplinary school team as described in Subsection (20)(a)

136	education and occupational preparation;
137	(b) all Board, local board and local charter board graduation requirements;
138	(c) evidence of parent or guardian, student, and school representative
139	involvement annually;
140	(d) attainment of approved workplace skill competencies, including job
141	placement when appropriate; and
142	(e) identification of post secondary goals and approved sequence of courses.

167	(a) understand and manage emotions;
168	(b) set and achieve positive goals;
169	(c) feel and show empathy for others;
170	(d) establish and maintain positive relationships;
171	(e) make responsible decisions; and

- 173 (29) "Split enrollment student" means a student who is:
- 174 (a) regularly enrolled at two schools within two LEAs at the same time;
- 175 (b) eligible for graduation and other services at both schools; and
- (c) subject to the split enrollment provisions of Rule <u>R277-419</u>, counted by each
   LEA in membership for purposes of generating state or federal funding for only those
- 178 courses or subjects for which each LEA provides instruction.
- 179 (30) "State Charter School Board" or "SCSB" means the State Charter School
  180 Board created in Section <u>53G-5-201</u>.
- (31) "Student Threat assessment" means a prevention strategy that involves: (a)
  identifying student threats including to commit a violent act, (b) determining the
  seriousness of the threat, and (c) developing intervention plans that protect potential
- victims and address the underlying problem or conflict that stimulated the threateningbehavior.
- 186 (32) "Superintendent" means the State Superintendent of Public Instruction or187 the Superintendent's designee.
- 188 (33) "Suspension" means:
- (a) an in-school suspension that is a temporary removal of a student from the
  student's regular classroom for disciplinary reasons for at least half a school day but
  remains under the direct supervision of school personnel; or
- (b) an out-of-school suspension that is the removal of a student from schoolgrounds for disciplinary reasons unless the student removed is:
- (i) served solely under a Section 504 plan, where an out-of-school suspension is
  the excluding of the student from school for disciplinary purposes for one day or longer;
  or
- (ii) a student with disabilities under IDEA, where an out-of-school suspension is
  the temporary removal of the student from the student's regular school for disciplinary
  reasons to another setting.
