# Informal Science Education Enhancement

Sen. Hinkins presented RFA: ISEE Provider Expansion and iSEE Sustaining Student Services with the assistance of Derrek Hanson, Executive Director, Red Butte Garden, Deborah Ivie, Utah State University Extension, Nick Hoffman, School Programs Manager, Red Butte Garden.

Rep. Thurston asked who chooses the RFP and recommends the flow from provisional to permanent programs. Deborah Ivie responded.

Rep. Thurston asked if this funding is one-time or an on-going request. Deborah Ivie responded.

Sen. Riebe commented that most of these programs are based along the Wasatch Front and wondered if they could be based in more rural areas to save money and bring jobs to those areas. Deborah Ivie responded.

Rep. Briscoe asked for an explanation of why the Child Nutrition Income Tax Fund is so low. Rachelle Gunderson responded.

Rep. Thurston asked what the 32 full-time employees, at a cost of \$3.5 million, do for the board. Ben Leishman responded.

James Moss, Board Chair, Utah School Board of Education and Scott Jones, Deputy Superintendent of Operations, Utah State Board of Education responded to the staff presentation.

Rep. Pierucci asked for an explanation of the 32 full-time employees that were previously brought up by Rep. Thurston. James Moss and Scott Jones responded.

Sen. Millner commented that Utah is 16th in the nation in terms of the number of high schools where students have access to computer science. She added that If Utah wants to be number one in the economy, we cannot be 16th in digital communication and technology skills.

Rep. Carol Moss asked why tech companies, such as Pluralsight, are asking for more employees when they are laying off hundreds. Vik Hockett and Will Clive responded.

Sen. Riebe asked why the 100 plus schools that do not provide computer science courses, don't use on-line courses through SOEP. Vik Hockett responded.
