The South Salt Lake Valley Mosquito Abatement District is one of these local districts permitted by statute. Mayor Kristie Overson has served as the City's representative on the District's board for the past four years. Mayor Overson's term expired on December 31, 2023. This resolution will re-appoint Mayor Overson to the District's Board for another four-year term.</p>

**A RESOLUTION OF THE CITY OF TAYLORSVILLE APPROVING THE
APPOINTMENT OF MAYOR KRISTIE OVERSON AS THE CITY OF
TAYLORSVILLE’S REPRESENTATIVE ON THE BOARD OF TRUSTEES OF THE
SOUTH SALT LAKE VALLEY MOSQUITO ABATEMENT DISTRICT.**

WHEREAS, the Taylorsville City Council (the “Council”) met in regular session on February 7, 2024, to consider, among other things, approving the appointment of Mayor Kristie Overson as the City of Taylorsville’s (the “City”) representative on the Board of Trustees of the South Salt Lake Valley Mosquito Abatement District; and

WHEREAS, UTAH CODE ANN. § 17B-1-202(1)(a)(vii) permits the creation of a local district to provide for the abatement or control of mosquitos or other insects; and

WHEREAS, UTAH CODE ANN. § 17B-1-304 requires that city representatives be appointed to the Board via resolution passed by the city’s appointing authority; and

WHEREAS, the South Salt Lake Valley Mosquito Abatement District (the “District”) is a local district created pursuant to UTAH CODE ANN. § 17B-1-202(1)(a)(vii); and

WHEREAS, Mayor Kristie Overson has served as the City’s representative on the District’s Board of Trustees (the “Board”) for the past four years; and

WHEREAS, Mayor Overson’s current term of service on the Board expired on December 31, 2023; and

WHEREAS, after careful consideration, the Council has determined that it is in the best interests of the health, safety, and welfare of the citizens of the City to re-appoint Mayor Kristie Overson as the City’s representative on the Board for another four-year term.

NOW, THEREFORE, BE IT RESOLVED that the Taylorsville City Council hereby approves the re-appointment of Mayor Kristie Overson as the City of Taylorsville’s representative on the Board of Trustees of the South Salt Lake Valley Mosquito Abatement District for another term.

This Resolution, assigned Resolution No. 24-04, shall take effect immediately upon passage and acceptance as provided herein.
