**WHEREAS**, on February 7, 2024, a public hearing to receive public comments and to consider amendments to the budget was held at 6:30 p.m. in the Taylorsville City Council Chambers located at 2600 West Taylorsville Boulevard, Taylorsville, Utah 84129; and

**WHEREAS**, the Council finds that it has satisfied all legal requirements required to amend the budget and hereby determines that certain amendments to the 2023-2024 fiscal year budget are necessary.

**NOW, THEREFORE, BE IT RESOLVED** by the Taylorsville City Council that the budget for the 2023-2024 fiscal year is hereby amended as set forth in the attached document titled “2023-2024 Fiscal Year Amended Budget.”
