Minutes approval from the December 13, 2023, Board Meeting

Ms. Ukena moved to approve the December 13, 2023, Board Meeting Minutes. Motion seconded by Ms. Poll. Motion carried unanimously.

Maintenance Report and Business

- -Mr. Loertscher reported that he and Mr. Stark were able to get the problem at the reservoir gate all cleaned out. They feel that if they can continue that maintenance in the spring and the fall that it should last for several years.
