CLOSING REMARKS

Commissioner Kamalu and fellow Commissioners were at the National Association of Counties Annual Legislative Conference last week. Commissioner Kamalu represents the County on a transportation subcommittee. During this conference, counties are given a voice to the federal government and vice versa; typically, there are proposals from counties to the federal government to consider. The counties heard from various subcommittees during this conference, including those focused on airport, railroad, highway, safety and other various subcommittees. A Commissioner from Larimer County, Colorado shared their experience on a project they were having trouble getting funding for; Commissioner Kamalu shared a quote from that Commissioner, "To get things done takes collaboration and determination." Commissioner Kamalu also attended a training for Federal Emergency Management Act (FEMA) while at the National Association of Counties Annual Legislative Conference where a Commissioner from Lahaina, Maui, Hawaii also attended. The Commissioner from Lahaina shared their experience with the devastating fire they suffered in August 2023. A presentation was given by a local business owner in Joplin, Missouri; Joplin suffered an EF5 tornado in 2011. The presenter highlighted how important it is to work on recovery right away, and to listen to the community about what they are seeing and what is happening in their immediate areas. Switching topics, Commissioner Kamalu said in Davis County from December to February is the perfect time to see eagles. People in Davis County travel from all around to see Davis County's eagles.
