• **Internal Dashboard:** During Phase 1, only 110 users had access to the internal dashboard, which limited the available features. With agency-wide adoption in Phase 2, all staff members would be able to:

- o search for staff members based on their detailed roles and responsibilities,
- o use the Pingboard mobile application on the go,
- play the "Who's Who?" game to put names to faces and learn new details about people in the agency,
- o provide praise to colleagues in a fun and seamless way,
- o and more.

## **Budget Proposal:**

To implement Pingboard across the entire Utah State Board of Education, \$25,000 would be needed to cover the annual licensing fees and ongoing support. This investment would contribute to the long-term effectiveness of our organizational chart, ultimately improving the services provided to our constituents and staff members.

- \$20,000 from state discretionary funds for FY2024, and
- \$25,000 ongoing funds from the Board's budget to sustain the Pingboard subscription for FY2025 and beyond.

By investing in Pingboard, the Utah State Board of Education aims to reinforce its commitment to transparency, accessibility, and efficiency. This agency-wide solution would empower our constituents, staff, and stakeholders to navigate our organizational structure effortlessly, thereby enhancing the overall experience of engaging with the Utah State Board of Education.
