AN ORDINANCE OF WILARD CITY, UTAH, REPEALING THE LOCAL OPTION SALES AND USE TAX FUNDING PUBLIC TRANSPORTATION THAT MAY BE IMPOSED UNDER UTAH CODE §59-12-2213.

WHEREAS, Willard City (hereafter "City") is municipal corporation duly organized and existing under the laws of the state of Utah;

WHEREAS, the Utah State Legislature previously adopted Utah Code §59-12-1001, which was transitioned under Utah Code §59-12-2212.1;

WHEREAS, The Utah State Tax Commission is presumptively collecting a sales and use tax in accordance with the Utah Code §59-12-2213, and the City desires to repeal the same;

WHEREAS, the City Council has the power to establish and repeal a sales tax on retail sales for the purpose of funding public transportation and transit;

WHEREAS, the City previously adopted Ordinance 2007-B(rev) and may have adopted additional Ordinances and possible agreements, to impose, pursuant to Utah Code §59-12-1001, a sales and use tax upon retail sales of 0.30% to finance public transportation for the City and now desires to repeal the same,

WHEREAS, notwithstanding Utah Code §59-12-2208, the City's Legislative Body is not required to submit this repeal to the City's registered voters;

NOW, THEREFORE, BE IT ORDAINED by the City Council of Willard City, Utah, as follows:

- **Section 1.** Repeal. Ordinance 2007-B (rev) hereby repealed in its entirety along with any other Ordinance that conflicts with this Section. The local option sales and use tax adopted by the City to fund public transportation in accordance with Utah Code § 59-12-1001 and presumed to be currently imposed under Utah Code §59-12-2213 is hereby repealed in its entirety.
- **Section 2.** Agreement. Any interlocal agreement or similar agreement related to the local option sales and use tax to fund public transit in accordance with Utah Code §59-12-2213 is hereby repealed and terminated in accordance with the terms of said agreement that may exist.
- **Section 3. Effect.** The City Recorder is authorized and directed to provide this Ordinance to the Utah State Tax Commission and comply with any other notice, documents, or related requirements to effectuate this repeal.
- **Section 4. Severability.** If a court of competent jurisdiction determines that any part of this Ordinance is unconstitutional or invalid, then such portion of this Ordinance, or specific

application of this Ordinance, shall be severed from the remainder, which remainder shall continue in full force and effect.

Ordinance No. <u>30</u>07 B(Rev.)

ORDINANCE INCREASING THE HIGHWAY AND PUBLIC TRANSPORTATION SYSTEM SALES TAX WITHIN THE CITY OF WILLARD CITY, UT, FROM ONE-QUARTER OF ONE PERCENT (.25%) TO THREE TENTHS OF ONE PERCENT (.30%).

WHEREAS, the City Council has the power to establish a sales tax on retail sales for the purposes of funding a highway and public transportation system pursuant to UCA Section 59-12-1001 or a public transportation system tax under section 59-12-501; and

WHEREAS, Willard City enacted a municipal highway or transit sales tax of 0.25% in 1996; and

WHEREAS, during the 2007 General Legislative Session the Utah State Legislature altered the State Tax Code to remove unprepared foods from the sales tax base of the transit sales tax; and

WHEREAS, the State Legislature anticipated that the removal of unprepared food from the sales tax base would negatively affect sales tax collections by municipalities which have imposed the transit sales tax; and

WHEREAS, the State of Utah provided for cities to increase the transit sales tax to 0.30% pursuant to UCA Section 59-12-1001 or up to 0.30% pursuant to UCA 59-12-501with the intent to reclaim a portion of said forfeited tax collections, and

WHEREAS, a city may increase the tax rate under Section 59-12-1001 to 0.30% or the tax rate under Section 59-12-501 to up to 0.30% on or after January 1, 2008, without being subject to the voter approval requirements enumerated in State Code,

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Willard that:

SECTION 1. REPEALER: The current ordinance levying a one-quarter of one percent sales tax imposed under Section 59-12-1001 or Section 59-12-501 hereby is repealed.

SECTION 2. ESTABLISHMENT OF A 0.30% HIGHWAY AND PUBLIC TRANSPORTATION SYSTEM SALES TAX: In addition to any other tax authorized by the laws of the State of Utah and/or of this municipality, there hereby is established, approved, and levied a sales and use tax upon the retail sales, as defined and included in UCA Subsection 59-12-103(1) and as restricted in UCA Subsection 59-12-501 (1)(a)(ii) or 59-12-1001 (1) (b), as amended, of three tenths of one percent (0.30%),

the same to be used in connection with the financing of a public transportation for the city of Willard City.

SECTION 3. EFFECTIVE DATE. This Ordinance shall become effective on January 1, 2008.

- **Section 1. Repeal.** Ordinance 2008-A and its accompanying Interlocal Cooperation Agreement, are hereby repealed in its entirety along with any other Ordinance that conflicts with this Section. The local option sales and use tax adopted by the City to fund public transportation in accordance with Utah Code § 59-12-2214 is hereby repealed in its entirety. The Interlocal Cooperation Agreement with the Utah Transit Authority is hereby terminated to effectuate this repeal.
- **Section 2. Effect.** The City Recorder is authorized and directed to provide this Ordinance to the Utah State Tax Commission and comply with any other notice, documents, or related requirements to effectuate this repeal.
- **Section 3**. **Severability.** If a court of competent jurisdiction determines that any part of this Ordinance is unconstitutional or invalid, then such portion of this Ordinance, or specific application of this Ordinance, shall be severed from the remainder, which remainder shall continue in full force and effect.

Section 4. Effective Date.

Pursuant to UCA Section 59-12-502, and in addition to the other sales and use taxes authorized by the laws of the State of Utah and/or this municipality, there hereby is established, approved, and levied a sales and use tax upon the retail sales, as defined and included in UCA Subsection 59-12-103(1), subject to the exemptions provided for in Section 59-12-104 and the exemption from tax for amounts paid for food and food ingredients, of .25%, the same to be used as provided by law.

SECTION 2. Effective Date. This Ordinance shall become effective as of April 1, 2008.



WHEREAS, Willard City (hereafter "City") is municipal corporation duly organized and existing under the laws of the state of Utah;

WHEREAS, the Utah State Legislature previously adopted Utah Code §59-12-2215, and, in accordance with the same, the City desires to impose an "option sales and use tax" to add a .30% tax to transactions described in Utah Code §59-12-2215 as provided by law;

WHEREAS, The City shall expend the sales and use tax collected under this Ordinance as described in Utah Code §59-12-2215,

WHEREAS, notwithstanding Utah Code §59-12-2008, the City's Legislative Body is not required to submit an opinion question to the City's registered voters in order to impose the sales and use tax adopted in this Ordinance;

NOW, THEREFORE, BE IT ORDAINED by the City Council of Willard City, Utah, as follows:

Section 2. Severability. If a court of competent jurisdiction determines that any portion of this Ordinance is unconstitutional or invalid, then such portion of this Ordinance, or specific application of this Ordinance, shall be severed from the remainder, which remainder shall continue in full force and effect.

1. Call to Order

- a. Mayor Travis Mote called the meeting to order at 6:30 pm.

2. Open Comment Period

Fred Ward, 235 S Main, Willard

"In the January 25, 2024, Council Meeting, you were presented with some requests from the Willard Canyon Access Coalition. Their mission is threefold: They want the fence taken down, they want the trail and trailhead improved, and they want a recorded easement for access to the canyon. They hope

to achieve this by collaborating with the city and those with property rights on the land of issue.

This statement leads me to believe that the coalition thinks the city are landowners in this issue.

My response to that is on the Box Elder County website, it indicates that the city owns none of the land in the canyon the coalition is talking about. In my view, the coalition is talking to the wrong people. The city should not have any involvement with this issue. The coalition also mentioned they are "reviewing which proposals they would like to put in front of the city, and they will engage with city officials to help them be clear on how you, the city, would like to see our proposals brought before you, the city." Once again, I would like to mention, this is not a city issue. As a taxpayer, I really don't expect the city to venture and spend the taxpayer's money on something the city has no responsibility for. This is an issue with the property owner.

My suggestion is the coalition should get with the property owners and stop this attempt to drag the city into picking sides and becoming the financial support for the coalition. Property owners have rights to protect and defend these rights. We as citizens, and all people, should honor and protect those rights too. In closing my statement to the Council is, I hope you take what I have to say seriously. As for my right to share my feelings, I hope that none of you have the same objective as the coalition. Thank you."

Mark Murphy, 180 W 100 S, Willard

"I would like to address the Council and the mayor and everyone else that's here regarding some comments which have recently been made. I am the co-chairman of the Willard Canyon Access Coalition, along with my wife. We are being supported by the International Outdoor Recreation Asset Alliance. We are working with them.

I'd like to clarify one thing, the reason that our coalition has brought so many in here recently to speak for access to the coalition's goals. That being, we know that the city holds the key to the property owned by the person in question, their land being mined. Without the city's cooperation, that's not going to happen. We are trying to get the city to move in that direction to pressure the property owner and help them to see that this is the way we need to go moving forward.

The second issue is the trails, which have been established up there for many many years. They are in fact a legal prescriptive easement. We are attempting right now to get the easement recorded by the county. We are coordinating with the county recorder and the county surveyor and the county sheriff to have this done. We do not want to litigate. However, we do have the resources to do so. That's the last thing we want to do.

We would like to talk with the owner of the property. He has not answered any of our attempts to speak with him. He refuses to speak with us. That's why we are doing what we are doing.

As eloquently stated, we have a threefold mission: all we want is to get that fence removed, to have the property easement and the trail recorded, and to have the trail improved and the damage that was done to the trail repaired. Thank you."

3. Planning Commission Report

Diana Baker gave the update. Ruth Beebe was sworn in as an alternate on the Planning Commission. There was discussion on the lot line adjustment for Marc Anderson's property on Tam's Road. It was passed. There was discussion on the rezone application from Marc Anderson as well. The rezone from A5 to R-½ was approved by the PC and moved up to the City Council.

There was a Conditional Use Permit reviewed for Matt Francom's welding business at 432 N Main. There was concern about it so they are drawing up more plans and will later present them to the PC.

There was a discussion about annexing South Willard and the Willard Annexation Police Declaration. The mayor has asked the PC to start doing a land use plan for South Willard if and when it is annexed in. An open-house was discussed and is being organized through the county. There was discussion about the public works and police department adjustments that may be necessary as well.

Jeremy Kimpton verified that the city ordinances have been posted online.
