Commissioner Anderson questioned the transfer of funds from a restricted account to purchase jet skis, and Utah County Sheriff James O. Tracy clarified there is some contribution from the sales of the old skis. Commissioner Anderson questioned whether the funds can only be used for emergency services, mentioning an email in which money had been requested for the medical account. He suggested medical needs could take priority over jet skis, and Wally Perschon of the Utah County Sheriff's Office detailed the account information. Commissioner Witney pointed out that tentative approval had been given for the transfer last week, but a major expense occurred over the weekend. Sheriff Tracy explained how an inmate swallowed a pencil, and then his own dentures later in the day; this led to two MRI scans.

Commissioner Ellertson summarized that this for the transfer of SR-146 to the county in exchange for North County Boulevard going to the Utah Department of Transportation (UDOT). Commissioner Anderson expressed confusion over the fact that the state is not taking over, and Commissioner Ellertson explained the state did not agree to the trade for the southern pieces. They discussed operating procedures and Commissioner Witney asked about the \$3,300,000 figure compared to the initial \$2,500,000 discussed, and Commissioner Ellertson clarified.

Commissioner Anderson stated he does not want the road. Utah County Public Works Associate Director Don Nay agreed, but stated it is not his choice. When Commissioner Ellertson noted the county made a commitment, Commissioner Anderson pointed out that the cities have not kept up their end of the agreement. Commissioner Ellertson stated he is still negotiating with the cities. Commissioner Anderson asked what would occur if the county refuses control of SR-146; Commissioner Ellertson mentioned there could be liability issues since the agreement was made in order for the county to purchase right-of-way with corridor preservation funds. Commissioner Witney also voiced his lack of excitement, and Commissioner Ellertson repeated that they can continue working with the cities.

Commissioner Witney asked about the county ability to clear the roads and Don Nay indicated it is possible. Utah County Deputy Attorneys Paul Jones, David Shawcroft, and Robert Moore approached to address legal concerns. Commissioner Ellertson requested a change to the language in Paragraph 2 in order to read "as determined by the county." Mr. Shawcroft and Mr. Moore explained how the cities are going to transfer before the county transfers to the state, and addressed liability issues. Mr. Moore and Commissioner Ellertson discussed deeds, and Commissioner Ellertson mentioned that UDOT is getting anxious.

Commissioner Ellertson made the motion to continue Regular Agenda Item No. 6 regarding a cooperative agreement with the Utah Department of Transportation for the transfers of North County Boulevard and SR-146 for two weeks to the November 18, 2014 meeting of the Utah County Board of Commissioners. They talked about maintaining a standard. Mr. Cortez explained how the crew works, and detailed how this expense will free up personnel to actually fight fires. Commissioner Witney expressed safety is a priority.
