The regular meeting of the Farr West City Council was held on January 8, 2015 at 7:00 p.m. at the City Hall. Council members present were Mayor Lee Dickemore, Matt Gwynn, Tom Burkland, Paul Dinsdale and Ava Painter. Boyd Ferrin was excused. Planning Commission Members present were John Stewart, Bruce Allen and Bonnie Beal. Staff present was Andrea Ortgiesen. Visitors present were: see attached list.

Mayor Lee Dickemore called the meeting to order. Mayor Dickemore led in the Pledge of Allegiance. Tom Burkland offered a prayer.

#### #1 – Public Comments

Mike Windley stated there has been concern in Miya Meadows with the students crossing the road to the junior high. He is wondering about an arc light or flags for the kids. Mayor Dickemore stated there is not a crossing guard required for the junior high and that is why the city spent a lot of money to put the sidewalks in. He stated the city is working on making it safer.

#9 – Discussion/Action – Possibility of creating a Youth City Council – Tyler Howard and Alex Hawley

Tyler Howard and Alex Hawley were present to discuss the possibility of creating a Youth City Council. Mr. Howard stated he feels it would be beneficial to the City. Ms. Hawley stated it would be nice to know how the City functions and what is going on with the City. Mayor Dickemore stated there was a Youth Council at one time and it was disbanded due to lack of involvement. He stated he is very supportive and would like to do some research to see about moving forward. John Stewart stated he was involved in the Youth Council and feels it was a very good organization. Ava Painter stated she feels this is a great opportunity and looks forward to re-establish a Youth Council and would offer her services getting it set up and going.

Paul reported the Wasatch Front Regional Council needs to hold their second public meeting and asked if the Planning Commission could move their work session to 6:00 p.m. on January 29<sup>th</sup> so they could hold the public meeting at 7:00 p.m. John Stewart stated they could make that work. Paul sated Randy Sant is moving ahead with the joint CDRA with Pleasant View meeting next Thursday at 3:00 p.m. Paul stated he will send out meeting minutes to the Planning Commission and City Council to keep everyone in the loop. Paul reported on the two Weber Fire District meetings. He reported on the ambulance in the upper valley as well as the updated fee schedule. Paul brought up home on 1900 w and stated it needs to come down. Mayor Dickemore stated he is working on it. Paul stated he has business license concerns with Heritage Ranch due to site plan issues. He stated they need to go through the same process as WISCO and come into compliance. He stated the city needs to keep in mind that it is a business and they should be treated as such.

Tom Burkland reported on the Storm Water Coalition meeting. He stated they had report of an oil spill on the corner of Millcreek at BDO. He stated there have been developments in enforcement of the MS4 permits and they are doing early planning for the water fair. Tom reported on the Central Weber Sewer Board meeting and stated the new 2015 rate structure is in effect. He stated Farr West City's rates will increase 1.82% on quarterly fees. Tom recognized Sean Lambert's service as chair of the Storm Water Coalition for the past year.

Matt Gwynn reported he met with Lou Waikart on the final part of the second stage of the emergency preparedness plan. Matt stated they will have a work session, hopefully by spring, to look at the plan. He stated he is looking into a joint emergency preparedness fair with Weber Fire District in the fall. Matt reported on the Animal Shelter Board meeting and stated the Sheriff is looking at the cities picking up the tab of the shelter director's wages.

Mayor Dickemore reported on the WACOG meeting and stated they are currently making their assignments. Mayor Dickemore reported the Rec Center is busy with basketball leagues and stated Jazzercise will be starting this Saturday. Mayor Dickemore reported the Wasatch Front Regional Council will be having a meeting regarding highways on Monday from 3:00-5:00 p.m. at Pleasant View City Hall and encouraged all interested parties to attend.
