## 2015 Legislative Session





#### Proposed Bills

- HB 31 Natural Gas Amendments
  - Increases fine authority because feds are cutting our pipeline safety program funding due to fines being too low
- SB 88 Public Utilities Amendments
  - Changes approval timeline for agreements between public utility and municipality

- Industrial customer issue regarding energy taxes
