- 1 15-11 Daniel Rivera vs. Attorney General's Office (Appealed 31 Mar). Mr. Rivera is appealing the denial of records relating to the termination of his parental rights in Feb. 2013. Missing governmental entities denial and original request. Incomplete notice of appeal to SRC.
- 2 15-13 Richard J. Garcia vs. Utah Department of Corrections (Appealed 2 April). Mr. Garcia is appealing the denial of transportation records from July 8, 2014, to present. Seeking records on all transportation departures and returns, dates and times, and policy regarding restraints. Missing governmental entity and chief administrative officer denials. Incomplete notice of appeal to SRC.
- 3 15-14 Karl Losee vs. Utah Department of Corrections (Appealed 2 April). Mr. Losee is appealing the redaction and denial of emails from December 2009 to March 31, 2010, involving him and the listed individuals on the GRAMA request. Missing governmental entity and original request. Incomplete notice of appeal to SRC.
- 4 15-15 Patrick Sullivan vs. University of Utah (Appealed 3 April). Mr. Sullivan is appealing the denial of his GRAMA request for medical records dating September 1, 2014 to present from the University of Utah, Medical Records Office. Missing governmental entity and chief administrative officer denial, and original request. Incomplete notice of appeal to SRC.

Hearing Declined:

5 14-60 Robert Baker vs. UDC (Appealed 8 Oct). Mr. Baker appealed the denial of receiving copies of Policy and Procedures at Utah State Prison and that UDC's interpretation of U.C. 63G-2-201(8)(a)(v)(A) was never appealed or legally challenged before the State Records Committee. On or about December 30, 2014, UDC reset the 100 copy allotment and provided copies of the policy to Mr. Baker. Hearing denied January 5, 2015 by Chair and second committee member because the subject of the appeal has been found by the Committee in a previous hearing involving the same governmental entity. Decisions and Orders 14-12 & 12-23. Mr. Baker has requested reconsideration for a hearing on January 29th and most recently March 5 & April 2. SRC denied Mr. Baker a hearing. The SRC will not respond to Mr. Baker's April 2, 2015, fourth motion for reconsideration. No such motion exists for a reconsideration once a case is denied. SRC jurisdiction is statutory that once a case is denied the petitioner has 30 days to appeal to District Court.

District Court Cases

Utah Dept. of Human Resources v. Paul Amann, 3rd District, Salt Lake County, Case No. 150901160, filed February 19, 2015.

Current Disposition: Complaint filed with the Court and answer filed on behalf of the Committee on March 11, 2015. A motion was made to seal the record, which was granted by the Court on March 9, 2015.

Daniel Rivera Jr. v. Utah Department of Human Services, Division of Child and Family Services, 3rd District, Salt Lake County, Case No. 150900589, Judge Toomey, filed January 27, 2015.

Current Disposition: Complaint filed with Court but no service yet on the Committee. Answer prepared to file once service has been completed.

Jordanelle Special Service District v. Utah State Auditor, 3rd District, Salt Lake County, Case No. 150900423, Judge McKelvie, filed January 20, 2015.

Current Disposition: Parties have agreed to dismiss the case pending the release of the audit by the Utah State Auditor.

Utah Dept. of Correction v. Campbell, 3rd District, Salt Lake County, Case No. 140906834, Judge Parker, filed October 1, 2014.

Current Disposition: Case dismissed on April 3, 2015 based upon Default Judgment for failure to file an Answer by Campbell (Buzzfeed).

Salt Lake City v. Jordan River Restoration Network, 3rd Judicial District, Salt Lake County, Case No. 100910873, Judge Stone, filed June 18, 2010.

Current Disposition: Decision from the Court granted motions for SLC regarding Jordan River's claims, but Court denied motion for summary judgment regarding the ultimate issue of the case (should the fee be waived for the records).
