**RESOLUTION ADOPTING THE FIVE YEAR CONSOLIDATED PLAN FOR  
THE COMMUNITY DEVELOPMENT BLOCK GRANT,  
(2015-2020)  
BETWEEN THE CITY OF TAYLORSVILLE AND  
THE U.S. DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT**

WHEREAS, the City of Taylorsville is entitled under 24 Code of Federal Regulations (CFR) Part 91, et al., to receive Community Development Block Grant (CDBG) fund from the U.S. Department of Housing and Urban Development. and

WHEREAS, it is in the best interests of the people of Taylorsville that the City submit a five year plan to HUD for said funds in accordance with 24 CFR Part 91; and

WHEREAS, the public notices, hearings and other pre-submission requirements as set forth in 24 CFR Part 91 have been accomplished by the City, including but not limited to the following: A public hearing held Wednesday, August 5, 2015 to consider the plan and to obtain views of citizens regarding the City's Five Year Consolidated Plan;

WHEREAS, the City Council does meet now this August 5, 2015 to adopt the City's Five Year Consolidated Plan for CDBG.

NOW, THEREFORE, be it resolved by the City Council of Taylorsville, Utah as follows:

1. That the City of Taylorsville hereby adopts its Five Year Consolidated Plan for CDBG.

2. That the Mayor, as the official representative of Taylorsville, is hereby authorized to submit the City's Five Year Consolidated Plan for CDBG, together with additional information and certifications as may be required under 24 CFR Part 91 to the U. S. Department of Housing and Urban Development.

3. That the Mayor, as the official representative of Taylorsville, is hereby authorized to sign and execute the HUD Grant Agreement if required.
