## **Respite at the Utah State Developmental Center (USDC)**

When the program began at USDC, there were a total of 57 units. That number is now well over 400 units.

What limitations are there for respite at USDC?

We can only serve those folks 18 and over. The amount of medical care can also limit services.  
Behaviorally, there are few limitations.

The Division will investigate the possibility of getting a nurse available at USDC.

The Division will investigate providing respite at USDC for younger population.

## **Draft Service Code introduction Flyer:**

The Division would like to provide the community with a brief information sheet on each kind of service available. The Division presented the first tool looking at the respite.

Feedback will be provided to Ryan and the Division will send to Health for approval.

**Request for Services Update:**

The Council will continue to review the criteria document for service codes that was sent out the previous meeting. Feedback from the Council should be submitted no later than September.

**Family to Family Network and People First Flyers**

The Council recommends the Division move forward with looking to include the Family to Family and People First Flyers in intake packets, surveys, and other information packages sent to families and service recipients.
