CITY COUNCIL MEETING 00:00:00

The City Council Meeting was called to order by Mayor Don Carroll at 7:05 pm.

2. APPROVAL OF MINUTES FROM PREVIOUS MEETING

Council Member Julia Busche made a motion to approve the minutes of January 20, 2015 with corrections. Council Member Craig Hill seconded the motion and it was approved unanimously.

4.1 Report from Fruit Height Youth City Council

No report was given.

4.2 Davis County Sheriff's Report

Lieutenant Jason Boydston from the Davis County Sheriff's Office reviewed the incident report for the City of Fruit Heights for the months of November 2014 through the end of January 2015. He reported that the City of Fruit Heights did very well during those three months. Mayor Don Carroll expressed appreciation for the Sheriff's Office and inquired as to what the City could do to remain a safe community. Lieutenant Boydston mentioned removing valuables from vehicles and locking vehicles. He also appreciated the citizens who remain observant and report suspicious activities.

4.3 Discuss/Approve/Deny Resolution 2015-001 Transportation Funding 00:21:47

City Mayor Don Carroll presented this resolution encouraging the State of Utah to address comprehensive transportation funding. The City Council discussed some of the wording that disturbed them. Council Member Craig Hill mentioned that the state needs money from this tax and that for the City of Fruit Heights it is the only money received for our roads. The City Council also discussed air quality and active transportation. Mayor Don Carroll expressed concern that the City may be asked to help pay for future active transportation projects. City Planner Jeff Oyler mentioned that the legislation may give the counties authority to increase taxes.

Council Member Craig Hill made a motion to approve Resolution 2015-001 with the changes suggested by the council. Council Member Julia Busche seconded the motion.
