ACTION:	Designation of an Alternative School by the State Board

Background: S.B. 245 *School Grading Amendments* (2015 Legislative Session) defines rules for school grading. In addition to accountability calculations, the law defines an "Alternative School" to mean a school:

(a) Established to serve youth who are not succeeding in a traditional school environment; and (b) *designated as an alternative school by the State Board of Education*.

An Alternative School or a special needs school can request a school grading accountability exemption from the State Board and, instead, have the school evaluated using the alternative accountability provision. The Data Governance Policy Board discussed options and is seeking direction from the Board in setting up the process a school would need to follow to apply for this designation.

Key Points: There are schools assigned as alternative and special needs before the legislation was enacted that do not have the State Board designation. Staff will present a proposal to the committee outlining a process for schools to obtain authorized Board designation.

East Hollywood High School has submitted an application to be designated as an Alternative School, and Board approval is needed.

Anticipated Action: The Board will consider approval of the process for designating an alternative school under the school grading system. The Board will also consider the designation of East Hollywood High as an alternative school.

Recommended steps for requesting an alternative school or special needs designation:

- 1. Charter School or District submits a letter of request to USOE staff:
 - a. Utah State Superintendent
 - b. Chief Privacy Officer
 - c. Director of Assessment and Accountability
 - d. Director of Student Advocacy Services
- 2. Application reviewed by Data Governance Policy Board which will forward application to the State Board of Education (Board) with recommendations.
- 3. The Board reviews the application and makes a determination:
 - a. Standards and Assessment Committee
 - b. Full Board (Consent Calendar)
- 4. Designation of School Type updated in USOE warehouse database

Questions for consideration:

- How long should designation last?
- What is the process for Charter School/District to re-apply if designation expires?
- How often should the Board review the list of schools?

Notes from 2015 SB0245

11 Highlighted Provisions:

- 12 This bill:

- 36 (1) "Alternative school" means a school:
- 37 (a) established to serve youth who are not succeeding in a traditional school
- 38 environment; and
- 39 (b) designated as an alternative school by the State Board of Education.
- 86 (5) (a) The board may exempt a school from school grading if the school:
- 87 (i) (A) is an alternative school; or
- (B) is a special needs school, as defined by rules made by the board in accordance with
- 89 Title 63G, Chapter 3, Utah Administrative Rulemaking Act; and
- 90 (ii) requests the exemption with the approval of:
- 91 (A) the school's governing board; or
- 92 (B) for the Utah Schools for the Deaf and the Blind, the school's advisory committee.
- 93 (b) If the board exempts a school under Subsection (5)(a), the board shall annually:
- 94 (i) evaluate the school in accordance with an accountability plan established by the
- 95 board through rules made in accordance with Title 63G, Chapter 3, Utah Administrative
- 96 Rulemaking Act;
- 97 (ii) report the results on a school report card; and
- 98 (iii) electronically publish the school report card in the same manner and at the same

Dear Aaron:

In a recent conversation with Ann White, she suggested I write you with a formal request that East Hollywood High School (EHHS) be given alternative school status. When EHHS was chartered, it was chartered with the express mission and purpose of being an alternative school that works with an at-risk population of high school age students. Since our charter was granted 11+ years ago, we have been true to that charter. Nearly all of our students are and have been considered at-risk of not graduating from high school. Our special education population averages between 20 and 25 percent. Well over 50% of our students are living in poverty. We are a Title I school.

Other than this letter of request, I am not certain exactly what is needed in this process. I am citing below quotes from the original EHHS Charter Application dated March 16, 2004. I am also enclosing minutes of the State Charter School Board meeting held on July 15, 2004, as well as the minutes of the State Board of Education meeting held on August 6, 2004. You will see in these minutes that our mission, as stated from day one, is to work with an at-risk population of students. Both boards unanimously voted to charter the school and board members were enthusiastically supportive of an alternative charter school, particularly one located on the west side of the Salt Lake valley.

Quotes from East Hollywood High School original charter application:

"As a group of educators, business professionals and concerned community members, we have come together with the common goal of opening and operating a charter high school for at-risk students in the Salt Lake City area. Many of the students we will be serving have dropped out or are in danger of dropping out of the public school system. Others are seriously behind, many of age to be juniors or seniors with insufficient credit to graduate by the age of 19. We desire to provide a positive and exciting learning experience in an inviting, safe, and stimulating atmosphere."

"Mission Statement: It is the mission of East Hollywood High School to provide a continuously challenging curriculum in a safe and nurturing learning environment for students who have been identified as being 'at-risk', and to prepare them for high school graduation. Our primary goal is to help students learn how to learn, to love learning, and to become responsible citizens and productive members of society."

"For many reasons too many youth are becoming discouraged in their pursuit of a high school education and are dropping out of school. Every year in the Salt Lake Valley more than 3,600 high school students drop out of school, as shown in the Enrollment and Dropout Report submitted each year to the Utah State Office of Education by each school district in the state. It has been estimated that as many as three times that number are seriously 'at risk' of not completing their high school education. Many end up on the streets, contributing to a rising crime rate, drug abuse and gang-related problems. It is clear that populations with high at-risk characteristics are rapidly growing. This alarming trend only promises to worsen in the future unless positive steps are taken to reverse it. In an effort to help these students to complete their secondary education, to prepare them for adult responsibilities, and to reverse the trends cited above, we [are requesting] to establish a charter high school targeting at-risk students in the Salt Lake City area."
