Commissioner Ellertson said this keeps coming back to us and we need to be sure we understand the dates and amounts, Soren Halladay said the base date is 2015 instead of 2016. The amount is \$66,000. The original completion estimate was for 10 years, but now they are asking to increase that time to 2029. They are proposing 75% from the county.

Larry Ballard said the reason that he's here is because this seems to be a big deal. He has a concern that this will be county-wide tax incremental financing and he believed TIF's would become county-wide What is missing here is that private business has some public costs and the burden is placed on the taxpayer. He continued the original concept of the TIF would shift to smaller businesses, but has now been shifted to big business, He said the local officials usually don't consider what the growth would be without the TIF. He asked that the Commissioners disapprove this request. If Orem decides to use a TIF, all of the other cities would do this. Mr. Ballard thought disapproval would be better.

Commissioner Ellertson said the taxes world be given to the City of Provo and he asked if this would start a county-wide precedent, Mr. Ballard said "yes". He expressed the understanding the mayors of the cities should have an understanding of this. Commissioner Ellertson said this is not the first time this was done in developing cities, and Commissioner Lee agreed, saying this is happening more and more. Mr. Ballard said this leads to regionalization, and this is his main concern. His purpose in speaking is to give more information.

Peter Anderson said his concern is the taxes. The purpose of the state constitution is to stop anything that is illegal and unconstitutional and he felt there has been a long time of playing favorites and giving money to big cities.

Commissioner Ellertson said he appreciates the fact that they compete and raise taxes, He said this consideration is to get cities moving on projects and he agreed it is important to be aware of ramifications in other areas, but finally it doesn't increase the taxes. David Shawcroft noted the incremental payment is just that; a payment.

Commissioner Lee said it is the consensus; that when we approve a TIF, the business is getting subsidies and Mr. Ballard said the county is playing favorites in these issues.

Commissioner Lee said this is about the free market system, in order to create, you must have some of these projects. His concern is that it does favor big business, so he would like to get a broader idea of this development, He said he doesn't get this and would like to address some concerns with Cameron and Soren to possibly restructure the request. He added, he would also be more comfortable with an amount lower than 75%.

Commissioner Graves asked what the basis for continuing this matter would be, and Commissioner Ellertson said he would like to take a week to be sure everyone understands this proposal.

PUBLIC COMMENTS

Larry Ballard read the following comments into the record:

At a time when local governments' efforts to foster development, from direct subsidies to the use of eminent domain to seize property for private development, are out of control, TIF's only add to the problem. There are hidden costs that taxpayers don't know about. Cities generally assume they are not really giving anything up because the foregone tax revenue would not have been available in the absence of the development generated by the TIF. That assumption is often wrong.

There is always this expectation with TIF's that the economic growth is a way to create jobs and grow the economy, but then push the costs across the public spectrum. What is missing here is that the cost of development private business has some public costs. Road and sewers and schools are public costs that come from growth. Unless spending is cut – and if TIF really does generate economic growth, spending is likely to rise, as the local population grows, the burden of paying for these services will be shifted to other taxpayers. Adding insult to injury, those taxpayers may include small businesses facing competition from well-connected chains that enjoy IF-related tax breaks. In effect, a TIF subsidizes big business at the expense of less politically influential competitors and ordinary citizens.

The original concept of TIFs was to help blighted areas come out of the doldrums and get some economic development they wouldn't otherwise have a chance of getting, The end game again is that this tax financing construct shifts the taxes being paid from wealthy corporations to small businesses and regular people. The rest of us pay taxes for normal services like public safety, building inspections and street maintenance. Those services come out of the general fund. As the cost of services goes up, and the money from the general fund is given to these businesses through a TIF, the tax burden gets shifted to the regular private citizens and small business owners who don't have the same political clout. It is a crummy way to treat your taxpaying, law-abiding citizens

Local officials usually do not consider how much growth might occur without a TIF. In Chicago the neighborhood Capital Budget Group, a coalition of 200 Chicago organizations that study local public investment looked at 36 of the city's TIF districts and found that property values were rising in all of them during the five years before they were designated as TIFs. The study showed that the city invested \$1.6 billion in TIFs, even though 1.3 billion in economic development world have occurred anyway. So the bottom line is that the city invested \$1.6 billion for \$300 million in revenue growth. Again, these TIF monies

are diverting tax money that otherwise world have been used for government services.

The NCBG study also found that the 36 TIF districts world cost Chicago public schools \$632 million in property taxes based on development that would have occurred anyway because the property tax rates are frozen for schools as well. This doesn't merely mean that the schools get more money. If the economic growth occurs with the TIFs, that attracts people to the area thereby raising enrollments. In that case, the cost of teaching the new students will be borne by property owners outside the TIF district.

Finally, let us focus on the fact that the TIF incentive is not being used for a non-profit, a library or a school. They are for-profit business that gains an advantage over competitors. Where the TIF is normally used to lure in big corporate business, the consequences for the small business community can be extremely detrimental. Taxes that would otherwise go to schools, libraries, fire departments, and other urban services are diverted to entice and subsidize large corporation enterprises. I would urge the Utah County Commission to disapprove this proposal.

Peter Anderson read his comments into the record.

It is the policy of the State of Utah that a free market system shall govern trade and commerce in this state to promote the dispersion of economic and political power and the general welfare of all the people. Each contract, combination in the form of trust or otherwise, or conspiracy in restraint of trade or commerce is prohibited. Except as otherwise provided by statute, it is also prohibited for any person to monopolize, attempt to monopolize, or combine or conspire with any other person or persons to monopolize any part of trade or commerce.

The Board of Utah County Commissioners meeting recessed at 10:05 AM to go into closed session.
