HULLINGER, KIM AND BARI L. OLSON, CYNTHIA T. AND GERALD BOYD, EDITH ANN THAYNE, MURIEL ELLIOTT, DENNIS AND KARLA THAYNE, RICK and DEBI MEINZER, TARL W. AND EGDA L. TAYLOR FAMILY TRUST, JAMES L. AND ROBYN L. O'KEEFE, AND ANTHONEY G. AND PATRICIA ERICKSON; AND PROVIDING FOR AN EFFECTIVE DATE.

**WHEREAS**, City annexed the Manila Township area in 1998 and made plans to install sewer infrastructure in the area; and

**WHEREAS,** City did pay for and install sewer infrastructure in the area, but did not install a sewer main in 4000 North; and

**WHEREAS**, the citizens who own property on 4000 North have utilized septic systems since the annexation took place; and

WHEREAS, some of the septic systems are now failing; and

WHEREAS, septic systems are disfavored over sewer connections for a variety of reasons; and

**WHEREAS**, the citizens of 4000 North have requested that they receive sewer services from Pleasant Grove; and

**WHEREAS,** City has determined that it is in the best interests of the citizens to finish the initial sewer project that was begun eighteen years ago; and

**WHEREAS,** City has determined that it is fair and reasonable to pay for a portion of the costs of installing the sewer main due to the delay completing the project which significantly increased the cost of the project; and

**WHEREAS,** Property Owner agrees that it is fair and reasonable to pay for a portion of the installation cost; and

**WHEREAS**, the parties have agreed on a proportionate split of the costs based upon what the cost to Property Owner would have been if the project was done in 1998 as planned; and

**WHEREAS,** City is willing to construct and pay for the sewer main line project 4000 North and Property Owners are willing to pay their proportionate share of the expenses as agreed; and

**WHEREAS,** City is entitles to be reimbursed by those individuals, corporations or other entities who shall benefit from the sewer infrastructure installation.



### **Construction Process**

Trails are an essential facility for the management of recreationsits and protection of natural resources. Durable pathways that highlight the native landscape provide visitors a minimally impacting and enjoyable recreation experience. Unfortunately, the vast majority of trails have not met sustainability benchmarks, which led Greg Mazu to found Singletrack Trails, Inc. Improving the outdoor recreation experiences while minimizing impacts to the land is constant in the company's trail construction resume.

Singletrack Trails is adamant about retaining the minimal construction footprint. Minimally impacting trails are created through a stepwise progression during the construction phase. Essential facets of every this construction process that ensure long-term sustainability include:

• Retention of seed-bearing organic matter for post construction vegetative recruitment and stabilization,

- · Micro-adjustments of trail alignments to avoid trees and protruding root structures,
- · Management of natural watershed drainage patterns through rolling contour construction, and

• Utilization of natural, on-site rock materials (if available) for hardening moist areas while maintaining natural soil chemistry.

Singletrack Trails is known for their "light touch" on the land by employing the minimum tool rule (the least impactful machine for the job at hand). While larger machinery may move more soil at a faster rate, it can also create substantial fill slopes that impact trailside vegetation. Our construction process has developed using smaller machinery and hand tools, to efficiently construct, while fully compacting and stabilizing the day's work before moving forward; this process results in a natural surface trail that is not subject to erosion during and immediately following the construction process. This efficient process keeps the construction crew moving forward and eliminates the need for "reconstruction" of trail after significant precipitation or freeze-thaw events that often occur during spring construction windows.





### **Construction Process**

The construction phase of the Pleasant Grove Trail Contruction Project will be completed using a combination of machines to create trails that each has a distinct style. Given the projects goals for trail system completion we have put together a timeline for construction that balances team efficiency and climate and weather constraints. Our 16 day construction window will accommodate a late summer opening of the trail system to public use (anticipated soft opening of August 31, 2016).

To meet this construction timeline, Singletrack Trails may need to supplement its in-house crew with an experienced team of Professional TrailBuilders Association partners that have successful mountain bike-focused trail construction experience. Each will be assigned a portion of the project that conforms to their particular expertise (i.e "flow" trail development, beginner/family-friendly trail, narrow and challenging singletrack, technical feature construction, etc.). This will also ensure the much needed diversity is integrated into the trail system, a condition that is rarely achieved on a production-oriented job undertaken by a single construction entity. Additionally, each team member has contractual engagements before and after this construction window, assuring an eye towards efficiency and quality control rather than change orders and extensions.

With Singletrack Trails contracted to manage the implementation process, project staff continuity will be provided to maximize construction productivity, ensure efficient rectification of issues (weather and equipment related) will be efficiently rectified, and necessary highest quality trail product. We feel that this project team and process are optimal and necessary to bring the Pleasant Grove trails on line before the end of August, 2016.

### **Contractor Equipment**

Singletrack Trails proposes to use the following machines during the construction of this trail project:

- Kubota U-17 or Equivalent
- Ditch Witch SK650 or Equivalent
- Sutter 480
- Canycom Mechanized Wheelbarrows

Singletrack Trails owns all machines listed by specific model number and will provide experienced operators with a minimum of 250 machine hours of operation.

### **Best Management Practices**

Singletrack Trails will adhere here to the following best management practices. At the request of the the Owner, Singletrack Trails will provide our Health and Safety Plan, Emergency procedures, and other related documents.

#### Site Access

The job site will be accessed via vehicle or hiking through access points approved by the Owner.

- Singletrack Trails will provide its own combination lock as approved by Owner
- · Vehicles will be parked in location approved by Owner and not in the way of existing trail traffic
- · Hiking will be contained on existing trails only
- If hiking is required to be made cross country, crew will use separate routes to minimize impact and creating a social route

#### **Mechanized Equipment Best Practices**

All track marks will be raked smooth- Affected area will be finished to have a nature shape, e.g., spoils piles rounded, smoothed and cleared of significant brush, blade edges blended. A spill kit suitable for five gallons of fluid will be onsite and within 500 feet of mechanized equipment whenever equipment is being operated. Scaring of trees is to be avoided. Machine service and fueling is not permitted with 100 feet of a wetland or drainage.

Machine access is restricted to the trail corridor. Separate access routes may only be created and used with prior written permission of the Owner. Any approved access route must be retired and reclaimed back to its original condition upon project

#### **Fire Prevention**

Fire prevention is an important part of protecting employees, company assets, and the project site. Fire hazards must be controlled to prevent unsafe conditions. Once a potential hazard is recognized, it must be eliminated or controlled in a timely manner. The following fire prevention requirements must be met for each site:

- A conspicuously located, 10B fire extinguisher for everywhere more than 5-gallons of flammable liquids or gas are stored.
- Generators and internal combustion engines located away from combustible materials.
- Site free from accumulation of combustible materials or weeds.
- No obstructions or combustible materials piled in the exits.
- No more than 25-gallons of combustible liquids stored on site.
- · Fire extinguishers located with each machine
- Fire extinguishers in the immediate vicinity where welding, cutting or heating is being done.
- Spark arrestor installed on each machine

#### **Machine Refueling**

Machine refueling will be made with portable 5 gallon fuel containers that will be transported to the worksite on as-needed-basis.

- No more than 5 gallons per machine will be stored on site in between fueling
- Fuel will be contained in containers free of leaks and punctures
- · Fire extinguishers will be located in the immediate vicinity
- Fuel spill kits will be located in the immediate vicinity



**Scope:** The completed Warner Mountain Bike Trail System is the result of 20-plus years of advocacy by the local mountain bike advocacy group, SORBA-MidTN. Located in the second largest city park in the United States after Central Park in New York City. The Metropolitan Government of Nashville established 100 acres of the park to be used for single use trail system designated for mountain bikers.

**Outcomes:** Partnering with Rock City Construction of Franklin, TN, Kay-Linn Enterprises, and Applied Trails Research to conceptualize and flag a nine mile trail system that provided a diverse riding experience that contained all dificulty levels. The project took nine months from start to finish. Singletrack Trails served the role of "prime sub-contractor" to organize the natural surface trail construction using additional subcontractors to complete the project with trail building machines and hand construction.

All nine miles of trail were constructed during a two month period. Singletrack Trails coordinated construction teams from eight different trail construction teams to best use the most appropriate contractor to build a specific trail for a specific trail flavor. At completion, eight trails were completed and each trail provided a unique riding experience.
