Action Taken Regarding Matters Discussed in Closed Session

Rhonda Perks, Field Representative for Congressman Chris Stewart, led the Pledge of Allegiance. All in attendance were invited to stand and join in.

Pledge of Allegiance Constitution Day Commissioner Petroff noted Constitution Day is September 17 and will be celebrated this year on September 16. He presented a brief history saying it was first celebrated in 2005. Also known as Citizenship Day, Constitution Day is an American holiday honoring the day 39 delegates to the Constitutional Convention signed the United States Constitution. This historic date was September 17, 1787. Few Americans know that September 17th is the birthday of our government. He read, "The ideals on which America was founded, commitments to the rule of law, limited government and the ideals of liberty, equality and justice are embodied in the Constitution - the oldest written constitution of any nation on earth." He then quizzed the audience with a few questions surrounding Constitution Day and encouraged us to think about these events.

Commissioner Millburn thanked Commissioner Petroff for his comments. He said he read an article in Sunday's paper asking folks what they would do if they were president of the United States. He was particularly impressed with Karem Abdul Jabar's response which was that he would make Constitution Day a national holiday. Commissioner Millburn said, "There is some real wisdom in that. We all celebrate our independence, but the reason we enjoy our freedoms is because of what is outlined in that great document and its amendments. He said politicians and citizens should remember our forefathers, especially as we step back and see what is happening on a national level today, especially in Congress. He said, "There is such a thing as compromise. Often times we forget that yes, you can have an opinion and you can debate, but at the end of the day, we are looking for solutions by which we all can live by. We need to look back at history and apply those principles."

Commissioner Petroff suggested we read David McCullough's book ["1776"] saying, "It's as good a history as you will ever read. You will get to find out what people were thinking and receive terrific insight into the lives of our forefathers and founders of our country."

2016 Commissioners' Cup Grant Applications are being accepted through November 1, 2016. The application can be found on the Davis County website. These grants are from funds raised at the annual Commissioners' Cup Golf Tournament to be used for educational programs for our youth.

The payable contract amount is \$145,000.00. Mack indicated they will be monitoring the outside temperatures to insure the repairs are done at optimal times.

Brian mentioned this program was started in Davis County and has now spread throughout the state. The receivable pass-through contract amount is \$20,000.00, of which \$18,000.00 will pass through to the Davis School District. The \$2,000.00 balance will be retained for administrative purposes. The contract period is July 1, 2016 through June 30, 2017.

Amendment #2010-229G adding language required by HUD to interlocal agreements with the cities of Sunset, Clinton, West Point, Farmington, Centerville, West Bountiful, Bountiful, Woods Cross, North Salt Lake, Syracuse, Kaysville regarding Community Block Grant Program Urban County Entitlement status. Michael Kendall, Davis County Assistant Chief Deputy Attorney, explained that these contracts run on the Federal fiscal year starting on October 1st for three years. They are automatically renewed unless they are terminated. HUD provides notice as they see fit when changes are necessary. They had a couple of additional items in this most recent notice required by all Urban County Entitlement counties. There is a separate interlocal agreement with cities similar to what the agreement is with Fruit Heights. That is why there is a requirement for the amendment to be made separately with all of the other cities.

Commissioner Smith said he attended the Utah Association of Local Boards of Health (UALBOH) Conference last week and came away being very appreciative of our local Board of Health. "Brian [Hatch] runs an excellent organization with a wonderful team and we are really blessed here in Davis County. It was a very good use of my day to spend it up there and understand some of the issues that boards of health face."

He also commented regarding the earlier conversation about Constitution Day. "The one part that always stands out in my mind is that the Constitution protects those who protest against it and attack it. That's part of the beauty of the document itself and also part of the irony with those who do have a tendency to take issue with the things that our country stands for. I'm not blind to some of the challenges, but very appreciative of that document and how it shaped our futures from the time we were little until way passed when we are gone."

Commission meeting reconvened.

Action taken regarding matters discussed in Closed Session to approve the sale of property. Tony explained the August 30, 2016 Commission Meeting Agenda item for the purchase of Tax ID 11-004-0059 was approved to be declared as surplus property. However, the real estate purchase contract with Scott and Jennifer Whetman was tabled. This property came to the county in 2012 in a tax sale. Taxes struck off at this sale were \$23,503.36. The property has been identified by Layton City engineers as having quite a few challenges on it. It has wetlands, slope failure, the majority is in a FEMA flood plain and a geo-technical study showing the potential for landslides has been provided to the County by Mr. Whetman. It has been deemed as unbuildable and the value of it is quite suppressed. Costs to improve and develop the property would be very high.

Commissioner Millburn asked if Mr. Whetman owned the abutting parcels in 2012 when the land was struck to the County. Tony does not believe he did. Real estate purchase contract #2010-355 and Quit Claim Deed were presented.

Commissioner Smith made a motion to approve the sale of the property as proposed. Commissioner Millburn seconded the motion. All voted aye. Tony will proceed with Mr. and Mrs. Whetman.
