STAFF RECOMMENDATION:


Staff recommends approval of a Resolution setting the 2017 Annual Meeting schedule for the City Council, Planning Commission, and other City Boards and Committees.

BACKGROUND DISCUSSION:

State Statute 10-3-502 outlines Meetings, Procedure, and Conduct, "...the council of each municipality shall: (a) by ordinance prescribe the time and place for holding its regular meeting..., and (b) hold a regular meeting at least once each month." During the past year, the City Council has generally held two meetings per month, on the second and fourth Wednesdays; with additional Workshops scheduled when needed.

The City Clerk is directed and authorized to publish a copy of the approved Annual Meeting Schedules 1) at the principal office of the public body; 2) on the Utah Public Notice Website, and 3) at least one time in the "legal notices" section of the **Salt Lake Tribune** newspaper.

RESOLUTION NO. 16-180

A RESOLUTION ADOPTING THE 2017 MEETING SCHEDULE FOR MEETINGS OF THE CITY COUNCIL, PLANNING COMMISSION, AND OTHER CITY BOARDS AND COMMITTEES

WHEREAS, Utah Code Annotated 52-4-202 requires that the City Council give notice once a year of its annual meeting schedule; and

WHEREAS, the City Council desires to establish the meeting schedule for the meetings of the City Council, Planning Commission, and other City boards and committees,

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF WEST JORDAN, UTAH:

Section 1. The City Council hereby adopts the 2017 Annual Meeting Schedules as listed below and attached as Exhibit A for the City Council, Planning Commission and other City boards and committees:

Meetings of the City Council. The City of West Jordan City Council will hold their meetings as outlined in the West Jordan Municipal Code, Section 1-13-3. (Specific dates attached)

Meetings of the Planning Commission. The Planning Commission will usually meet on the first and third Tuesday of each month with a pre-meeting at 5:30 p.m. and 6:00 p.m. for the business meeting, except on those dates where the meeting is canceled. Special meetings may be held at such times and locations as designated by the Planning and Zoning Commission or the City Council and for which public notice shall be given. (Specific dates attached)

Meetings of the Board of Adjustment. The Board of Adjustment will usually meet on the second Tuesday of each month at 6:00 p.m., as needed.

Meetings of other Boards, Commissions and Committees. The Arts Council, Budget Committee, Design Review Committee, General Plan Committee, Healthy West Jordan Committee, Historic Preservation Commission, Parks and Open Land Committee, Sister City Committee, Strategic Planning Advisory Committee, Sustainability Committee, West Jordan Events Committee, West Jordan Youth Committee, Western Stampede Committee, and will meet as needed.

Location of Meetings. All meetings described above, except those meetings for which notice is given that the meeting will be held at a different location, will be held at City Hall, 8000 South Redwood Road, West Jordan, Utah. Council Meetings may be held at other

locations as necessary and as lawfully designated by the City Council.

Section 2. The City Clerk is directed and authorized to publish a copy of the foregoing Annual Meeting Schedules 1) at the principal office of the public body; 2) on the Utah Public Notice Website, and 3) at least one time in the "legal notices" section of the Salt Lake Tribune newspaper. When so published, this public notice of the foregoing meeting schedule shall be deemed to have been given for the calendar year 2017.

Section 3. This Resolution shall take effect immediately.
