### **Background:**

Layton City and Mr. Fred Meese propose an agreement for the acquisition of property for Layton City's future South Fork Open Space Trailhead, to be located at 1381 East Heather Drive, Layton, Utah. Mr. Fred Meese is one of the property owners on Heather Drive whose property has been identified for purchase in securing land for the development of the future trailhead. This trailhead will allow neighboring residents access into the South Fork Open Space park property which is located on the South Fork of Kays Creek.

The property owner is willing to sell his property to the City for a significantly lower price than current market price. The total size of the property is 0.349 acres, parcel number 10-008-0053.
