Michael Moake, Davis County Legacy Events Center Marketing Coordinator, presented agreement #2016-466 with the North American Grappling Association for space to have a grappling tournament. Mike said the Association was very happy with the success of their previous tournament at the LEC and excited to hold it here again. The receivable contract amount is \$3,040.00. The contract period is March 23-25, 2017.

Commissioner Millburn made a motion to approve. Commissioner Smith seconded the motion. All voted aye. The document is on file in the office of the Davis County Clerk/Auditor.

Barry Burton, Davis County Community & Economic Development Director, presented agreement #2016-389 with Rural Community Consultants to produce a Davis County Resource Management Plan. The payable contract amount is \$not to exceed \$40,000.00. The contract period is through April 28, 2017.

Commissioner Millburn made a motion to approve. Commissioner Smith seconded the motion. All voted aye. The document is on file in the office of the Davis County Clerk/Auditor.

Tony Zambrana, Davis County Grants Auditor, presented Amendment #2016-281A with the U.S. Department of Housing and Urban Development (HUD) for the Community Development Block Grant (CDBG) Annual Action Plan. Tony explained HUD recently required that we spend 90% of the year's allocations. In order to do that, amended allocation increases were made to the following budget line items:

Davis Community Housing Authority's Down Payment Program - \$50,000.00 to \$100,000.00 Emergency Repair Program - \$15,000.00 to \$35,000.00 Davis Behavioral Health's Housing Acquisition Program - \$150,000.00 to \$200,000.00 North Salt Lake's Home Repair Program - \$50,000.00 to \$70,000.00.

The total receivable CDBG fund amount is \$819,678.00. The contract period is July 1, 2016 through June 30, 2017.

Commissioner Smith made a motion to approve. Commissioner Millburn seconded the motion. All voted aye. The documents are on file in the office of the Davis County Clerk/Auditor.

Brian Hatch, Davis County Health Department Director, presented grant application #2016-467 for funding to encourage public education and awareness of proper disposal of used oil. The receivable contract amount is \$2,024.52. The contract period is November 16, 2016 through May 16, 2017.

Commissioner Smith made a motion to approve. Commissioner Millburn seconded the motion. All voted aye. The document is on file in the office of the Davis County Clerk/Auditor.

Commissioner Smith presented amendment #2015-327E with the Utah Department of Human Services, Division of Substance Abuse and Mental Health (DSAMH) for an additional allocation of reimbursement for contract services for the Parolee Access to Recovery (PATR) program. The receivable contract amount for PATR is \$115,255.00 with a pass-through to Davis Behavioral Health. This brings the total receivable funds amount to \$3,373,056.00. The total Local Authority match during FY2017 is \$268,320.00. The contract period is July 1, 2015 through September 30, 2020.

Commissioner Smith made a motion to approve. Commissioner Millburn seconded the motion. All voted aye. The document is on file in the office of the Davis County Clerk/Auditor.

Commissioner Millburn made a motion to convene as the Board of Equalization. Commissioner Smith seconded the motion. All voted aye.

Curtis Koch, Davis County Clerk/Auditor, presented the Property Tax Register which reflects 4

stipulated appeals, 4 appeals that were denied change in value based on evidence provided, 7 approved after hearing, 3 late abatements for 2016 and 1 value correction for 2016.

Commissioner Millburn made a motion to approve. Commissioner Smith seconded the motion. All voted aye.
