1607	Discussion 2016- 2017 Budget Review	Bill Rappleye	Need to go through MOU, reviewed supply money has been cut off.
1611	Eagle Project Review	Scott Chatwin	Still needing suggestions for eagle scout projects. Have groups interested. Suggested re-organization of CERT trailers with expiration dates and excel spreadsheets. Seven boys that are working on projects, 6-8 live scouts, went over the workbook. Train the trainer first and working with UFA to then turn over to Draper fire. Potentially bring scouts into CERT. [Scott P] – Summit academy talk about faculty and staff training. 6 guys at end of January and early February getting trained to utilize to train other businesses.
1615	Training and Exercise schedule, District, School and Hospital Coordination	Scott Chatwin	Re-visited the 2017 and 2018 training plan. Talked about draper days. Channing hall did a lockdown drill 12/6/16. [Nolan] – Every summer waterpro does a big water quality report. Yearly review of the valves, controls, functionality for emergency management. They also perform a training for 4 th graders up at the treatment plant in March. Emphasis on where water comes from, water conservation and emergency management. [Scott C] – suggested maybe an adult/business version of WaterPro 4 th graders visit. [Tom] – mentioned that the last week in June (23 rd and 24 th) is field day and to add to training calendar. [Scott C] – plan to have shakeout with districts doing events and coordinated through city. [Clint] – Draper will still be utilizing UFA's equipment, Draper fire won't have own equipment until later mid-year.
1640	HAM repeater for Lake Mountain Site Discussion	DHRA	Discussion of Draper Days HAM radio operations for event coordination and practice. [Tom] Previous belief that the shadow on south mountain rendering citizens on other side "dark". Expensive to place another repeater. Re-tested and every inhabited area was fine with one shadow on part of Timpanogos hwy from

1650	CERT program manager appointment Brian Wright/Thank Brady Sines	Bill Rappleye	factory to I-15 and around the point to Exit 146 by Liberty Hill condos. After second evaluation, no repeater necessary. [Scott C] – historical information is that Draper bought 5 repeaters (including a mobile unit). Start to re-evaluate radio equipment and re- allocate as necessary. Introduced Brian to take over CERT coordination, Brady Sines had to decline. [Scott C] – we are hands on for CERT in May. Discussed training options and dates at library and other locations. Coordination to manage future CERT program through Draper versus UFA. Will need to start budgeting for CERT equipment once in Draper operations.

Trialing them in the public works area to ensure functionality. No fees, just Draper frequency. Digital, requires the repeater on 114th. 16 channels. Headsets help with clarity. Budget for handsets on next round.

Re-evaluation of IHC and Lone Peak Hospital to be placed higher on list based upon consequence score. Skaggs and mortuary not on the list. Dre will get the info on the body bags that prevent odor issues.
