Becky stated she is opposed because of her interpretation of the R-1-15 code and the density requirements, commenting she feels this development allows for too many smaller lots.

#2 - Motion – Recommend Final Approval of Golden Eagle Estates Subdivision located at approximately 1125 North 1200 West – John Hansen

John Hansen and Brent Bailey were present seeking final approval of Golden Eagle Estates Subdivision. John Stewart stated there were complications with the irrigation ditch which have now been rerouted. John then went over the recommendation in the Kent Jones memo dated May 18, 2017. Lou Best asked if the irrigation ditch is open or piped. John Stewart stated it is piped.

BECKY BROOKS MOTIONED TO RECOMMEND FINAL APPROVAL OF GOLDEN EAGLE ESTATES SUBDIVISION LOCATED AT APPROXIMATELY 1125 NORTH 1200 WEST. LOU BEST SECONDED THE MOTION, ALL VOTING AYE WITH GENNEVA BLANCHARD ABSTAINING.
