Waiver Request:

To allow Itineris to better align its curriculum with its STEM and early college focused mission, Itineris requests that the USBE allow Itineris to align its graduation requirements of Art and Physical Education requirement provided to that of its partnering University (SLCC).

- 1) Itineris would continue to require 0.5 HS graduation credits of Health Education
- 2) Itineris and SLCC would require 1.0 HS graduation credits of PE (waiver of .5 credit)
- 3) Itineris and SLCC would require 1.0 HS graduation credits of Arts (waiver of .5 credit)
- 4) Itineris would then require students to complete an additional 1.0 HS graduation credits from a combination of any of the following above and beyond the regular state requirement:
 - a. STEM/Early College High School option through Itineris or SLCC program:
 - i. Science
 - ii. Technology
 - iii. Engineering
 - iv. Mathematics

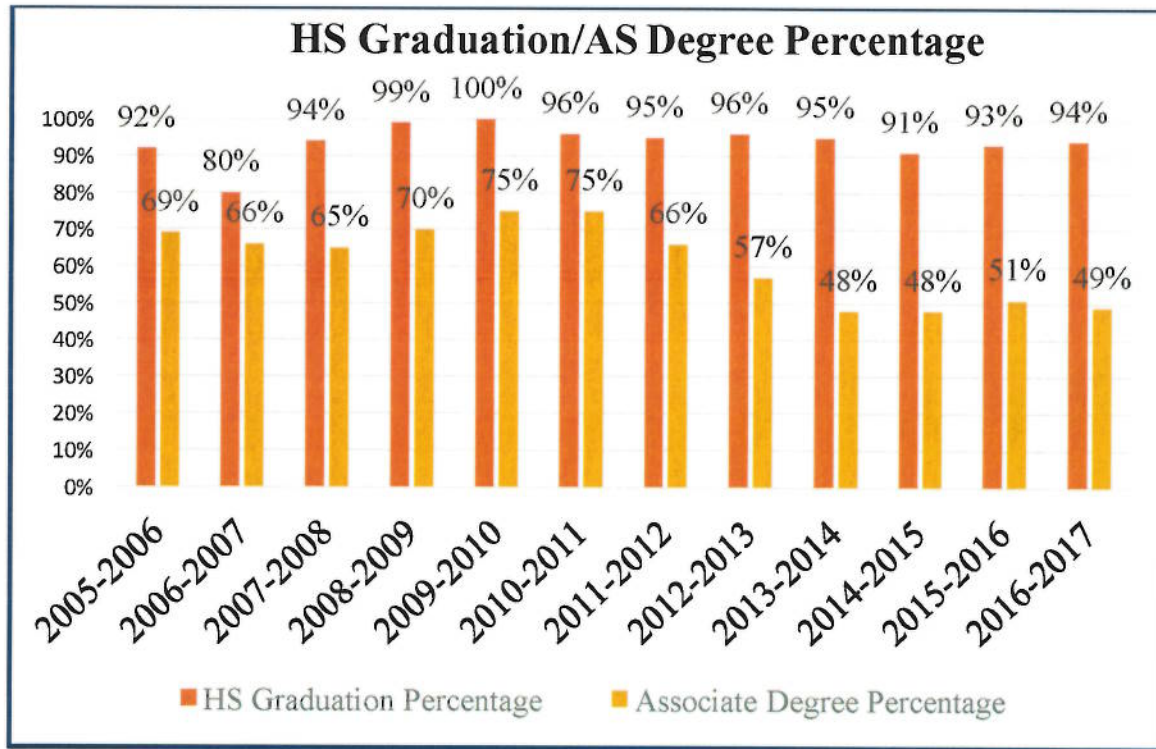

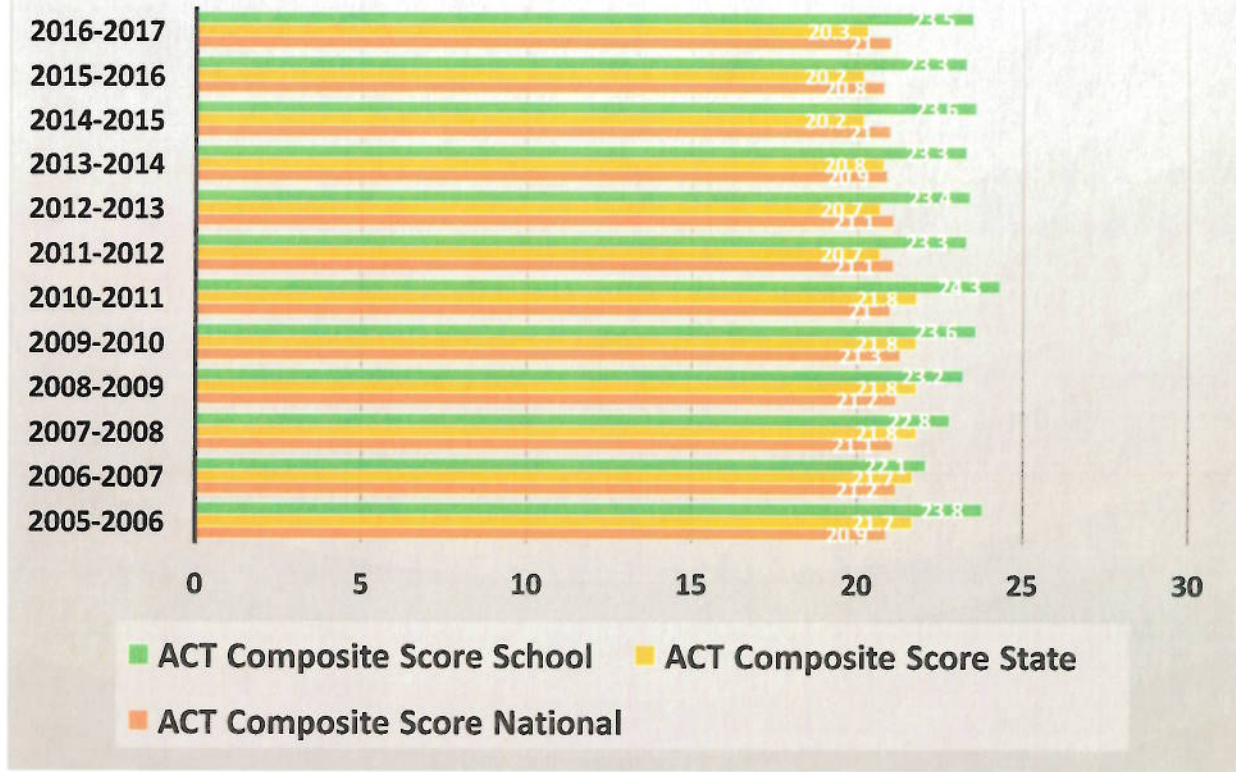

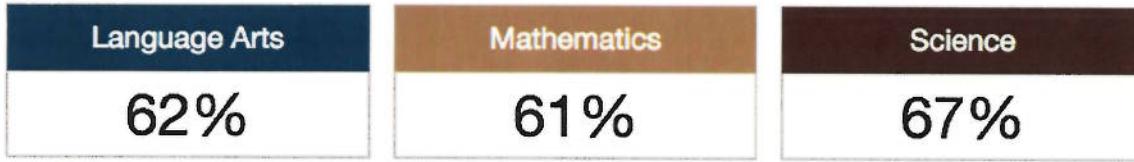
Itineris High School Graduation Rate and Associate’s Degree Percent

ACT Composite Scores 2005-2017

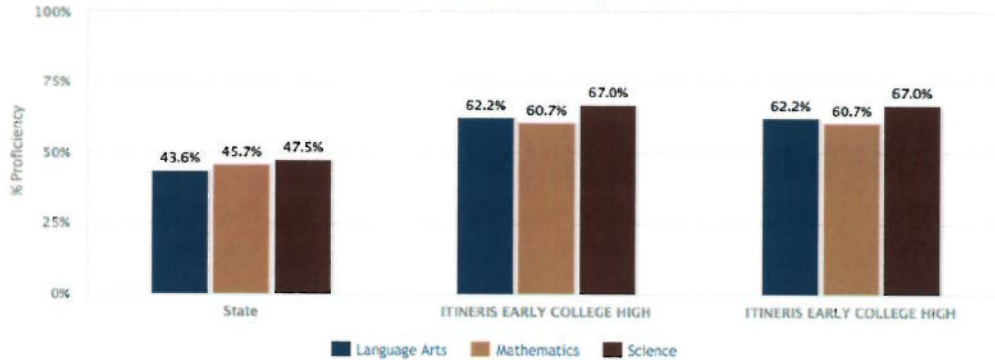


Itineris Composite ACT Scores Compared to State and National
