The Salt Lake City Planning Division is holding a meeting to discuss the *Euclid Small Area Plan*. The plan covers the Euclid neighborhood, which extends east to west from Interstate 15 to the Jordan River and north to south from North Temple to Interstate 80. The purpose of the *Euclid Small Area Plan* is to set forth goals for the redevelopment and growth of the Euclid neighborhood. These goals will be met through a series of short-, mid- and long-term strategies that Salt Lake City will work to implement.

The Planning Division will be explaining the process remaining for the master plan adoption and addressing any questions or concerns you may have regarding the plan itself or the process. Additionally, we will be discussing the recommended zoning changes to many of the parcels in the Euclid neighborhood that will be part of the plan's implementation.
