Commissioner Ellertson asked about the condition of the radios to be declared surplus to Search and Rescue, questioning why they were to be written off if they are still useable. Utah County Public Works Director Richard Nielson explained that the radios are not compatible with the multi-band system used by county patrol employees, and Jerry Monson of the Utah County Sheriff's Office confirmed that information.

Thompson noted the need for an additional \$8,629.00 to fund the Specialist III position for the rest of this year, and Commissioner Ellertson indicated monies should be available because the other position has not been filled for the last six months. Commissioner Witney also pointed out that these are one-time funds, and Mr. Thompson suggested adjustments going forward.

Utah County Community Development's Peggy Kelsey came forward to address the Board. She mentioned that there had been a meeting approximately one month ago involving Utah Highway Patrol (UHP) and the Utah Department of Transportation (UDOT) to address traffic and safety concerns regarding this art exhibit, which is expected to attract many members of the public. Both UHP and UDOT were willing to work with the proposal.

Peggy Kelsey introduced Jeff Lambson, Curator of Contemporary Art and contact for this project. He also spoke about cooperation between the UHP, Utah County Sheriff's Office, and Brigham Young University Police in creating the safest environment possible for this situation. Signs will be posted near Bridal Veil Falls to alert drivers. They are anticipating having between ten and eighteen offers on site. Mr. Lambson also addressed insurance policies.

The commissioners asked for details on this event, which will be a consecutive Thursday, Friday, and Saturday nights in October of this year from 7:00 PM to 11:00 PM. Jenny Holzer has presented at renowned establishments such as The Musée de Louvre in Paris, France and the Guggenheim Museum in New York City. She recently visited Bridal Veil Falls and was inspired to bring a projection show to Utah County. Jeff Lambson has worked at the Smithsonian Institution in Washington, DC and is impressed by her conceptual art which involves literary projections onto large structures. This event will be mentioned in international art magazines, bringing much positive publicity for the BYU Museum, Provo, and Utah County.

# 6. ADOPT A RESOLUTION AUTHORIZING THE COMMISSION CHAIR TO SIGN AN INTERLOCAL AGREEMENT WITH SANTAQUIN CITY FOR THE CREATION OF A RAILROAD QUIET ZONE IN THE SANTAQUIN AREA

Utah County Public Works Director Richard Nielson explained that Santaquin City has requested this agreement for a Quiet Zone around certain railroads in their area. There are six public crossings and three private ones involved. Commissioners Anderson and Ellertson had safety concerns about omitting the train horns, and Mr. Nielson noted that all of the public crossings are up to standards but he has not investigated the private crossings.

Commissioner Ellertson summarized that this interlocal agreement only gives Santaquin City the ability to submit an application to the railroad for the Quiet Zone. The agreement states that the county would pay their share of the costs for the crossings, but all of the improvements are already in place; further costs are not anticipated. Commissioner Witney mentioned that the county is not somehow supporting any private crossings, and Commissioner Anderson noted that Santaquin would essentially be representing Utah County in an association with the railroad. They discussed liability, and Utah County Deputy Attorney Paul Jones pointed out that it would not be an issue for the county.

Commissioner Ellertson made the motion to adopt the resolution authorizing the interlocal agreement with Santaquin City for the creation of a Railroad Quiet Zone as detailed in Regular Agenda Item No. 6. The motion was seconded by Commissioner Anderson and carried with the following vote:
