1. **Roll Call and Consent Agenda [00:00:04]** At 9:48 am, Chair, Mayor Troy Walker welcomed all attendees. Roll call was taken around the room, Jordon read online attendees.
  - a. **ACTION [00:02:05]** Mayor Walker asked for a motion to approve the minutes of the ATC meeting held April 12, 2023. Mayor Dirk Burton made a motion to approve the minutes, Mayor Braden Mitchell seconded the motion. No discussion, the minutes were approved unanimously.
2. **Chair's Report [00:03:08]**
  - a. Mayor Troy Walker gave a recap of Bike Month, and some of the big bike events that took place across the Wasatch Front in the month of May. Mayor Dirk Burton spoke about the Bike Summit that took place in West Jordan, and growing interest in e-bikes.
  - b. **[00:12:20]** Mayor Troy Walker announced that WFRC was awarded the Silver Level Bicycle Friendly Business.
  - c. **[00:14:25]** Mayor Walker asked if anyone from the public wanted to make a public comment.
    - i. *Spencer Riehl, Taylorsville resident, spoke about bike lanes being separated from car lanes, and the dangerous roads that people are biking on.*
3. **Presentation: Vulnerable Road User Safety Assessment [00:20:38]** Mayor Troy Walker introduced Thomas McMurtry with Avenue Consultants who spoke about UDOTs Vulnerable Road User Safety Assessment, which aims to identify areas of high safety risk to people biking, walking, and rolling. Mr. McMurtry gave some of the statistics and trends that the assessment has revealed using data from the last 6 years.
4. **Introduction: American Heart Association [00:44:52]** Mayor Troy Walker introduced Noah Miterko with the American Heart Association. Noah spoke to the organization's effort to improve health through changes in the built environment. Mr. Miterko talked about how the American Heart Association supports the work being done by the Active Transportation Committee.
5. **Update: Copperton Active Transportation Plan and Connectivity Ordinance [00:55:47]** Kayla Mauldin, Long Range Planner of Greater Salt Lake Municipal Services District introduced the Copperton Active Transportation Plan, and some of the objectives they want to address in their plan, as well as some of their ideas to get Community buy in. **[01:01:22]** Tim Sullivan with Township + Range Community Planning discussed the Connectivity Ordinances that are being funded by the Transportation and Land Use Connection Program, in the Copperton Active Transportation Plan.
6. **Presentation: AT Funding Overview [01:12:51]** Hugh Van Wagenen, WFRC spoke to the state and federal funding opportunities and grants available for Active Transportation projects. Mr. Van Wagenen also touched on the funding matrices for state and federal funding.
7. **Other Business [01:18:19]**
  - a. Jory Johner, WFRC, announced that the 2023-2050 Regional Transportation Plan was adopted. The Wasatch Choice Vision update will be released in August, and the Unified Transportation Plan will be forthcoming in September.
  - b. The TIF Active and TTIF First/Last Mile nominations will open on June 26, 2023.
  - c. Stephanie Tomlin was appointed as the Trails Division Leader at UDOT
  - d. The next Active Transportation Committee meeting will be on August 9, 2023
8. **Adjournment [01:22:00]** Mayor Braden Mitchell made a motion to adjourn, Mayor Dirk Burton Seconded the motion. No discussion. Meeting adjourned at 11:10 am
