- Principal and Academica West Evaluation – Monte Poll asked Ryan to spend 15 minutes to highlight the best things of his evaluation data. Ryan touched on the state's climate survey results which the state writes the questions and the school just sends the link to the stakeholders. The state sends the data back to the school. Ryan also went through some of the assessment data that is available, and current and past enrollment numbers. There was a discussion on what is our relationship with the Ministry of Spain and the State DLI coordinator, possibly using more of the Spanish speaking teachers not from Spain and how that effects the Spanish program/Spain culture, how the marketing going to increase our enrollment back to 1,000, community outreach, faculty training opportunities, number of opportunities for 1-on-1 meetings with individual faculty members, and Ryan's personal development. Ryan asked the board if there were other things that they would like him to report on. There was a discussion on the communication between the board and Ryan as well as the between the board members. There was a discussion on the evaluation tool and if it is something that may change. As of today, the board would like to keep the current evaluation tool. Academica West went through their data including financial statement, long term maintenance plan, on-going maintenance by AW, maintenance tickets, compliance, training, and a year at a glance. Monte wanted to reiterate how impressed he was with how professional manner that the fraud was handled this last year. It was the best way to go through one of the worst experiences any of us could have delt with as organizations collectively. On the record, it speaks volumes for what type of group we have here. AW is very quick to respond to any compliance emails sent from the state. They feel like they are receiving special treatment but after asking around, other schools have reported that they are receiving the same service.
