Chairman Evan Curtis officially called the Navajo Revitalization Fund (NRF) In-Person Board meeting to order at 1:06 pm, on Thursday, May 25, 2023, virtual meeting with an anchor location at 140 East 300 South, Salt Lake City, UT 84111, and an electronic Zoom option.

4a. NRF Applicant Policies and Procedures

Paul Moberly went over the annual Navajo Revitalization Fund Administrative Policies and Procedures. These practices will be shared with applicants. Suggested changes to the board of changing \$85,000 housing projects to increase or stay the same. Herman Farley stated that maybe there should be a 60/40 matching requirement on new houses due to rising costs. Tony Dayish stated that the Trust Fund is currently using the square foot cost (\$105sf). There is also a cost structure based on family size. This topic will be discussed at future meetings.

Reporting requirements are a little newer than what we are used to. This is a living document and can be changed and discussed anytime the board feels the need to address their policies and procedures.

Mr. Dayish also recommended several revisions on the non-chapter funding allocation procedures.

Commissioner Patricia Blackhorn made, and Commissioner Larry Tuni seconded the motion to adopt the Navajo Revitalization Policies and Procedures with suggested changes by Tony

Dayish. The motion carried as approved with affirmative votes by Commissioner Jamie Harvey, Patricia Blackhorn, Larry Tuni, Commissioner Silvia Stubbs, and Chairman Curtis.

This will change the grant recipient from NUC to Dennehotso Chapter to facilitate expenditure of remaining grant balance. This will be a direct contract with the Dennehotso chapter with contract language to include allowance for reimbursement of expenditures from original date of board approval (10-27-2015)

This project for new home construction for Herman Norton, with partner funding from the Navajo Trust Fund. It will be completed by Design Build Utah – Bluff.

5.d Red Mesa – Home Renovation – Betty Sitnajinnie – Approved \$2,606.79 [00:45:43]

This project is new roofing materials and vinyl flooring for Betty Sitnajinnie's home. No Utah Navajo Trust Fund monies are involved.

5.e Navajo Mountain – New Home – Leonora Lameman & Bryon Sloan – Approved \$23,406 [00:46:59]

This is supplemental funding to complete the 28 x 44' 3-bed, 2-bath home for Leonora Lameman & Bryon Sloan, due to cost increases.
