5.0 Report: Proposed property tax increase by Jordan Valley Water Conservancy District (JVWCD) for water service purposes

5.1 Reed Gibby, Draper representative on the Jordan Valley Water Conservancy District (JVWCD) Board of Trustees, reported that reservoirs were filled following the winter snowpack, but rainfall had been lower than average in June and July. Mr. Gibby spoke of population growth and aging infrastructure and said the JVWCD Board was proposing a property tax increase for FY 2024 to fund needed capital projects.

5.2 Alan Packard, JVWCD CEO, and General Manager, applauded the Council for adopting water efficiency standards. He said property tax made up 25% - 30% of JVWCD revenue, and explained that property tax revenue affected JVWCD's bonding ability. Mr. Packard spoke of needed capital projects and said the Board proposed a 9.3% property tax increase for FY 2024. Responding to a question from the Council, Mr. Packard confirmed the JVWCD Board raised the property tax rate in FY 2023. A JVWCD public hearing was scheduled to occur on August 9, 2023, at 6:00 p.m. at 8215 South 1300 West in West Jordan.

5.3 Mayor Walker opened the meeting for public comment, but seeing no one come forward he closed the public comment. Mayor Walker noted that no Council action was required.

6.0 Action Item: Resolution #23-39, a Resolution of the Draper City Council granting preliminary approval for the withdrawal of the Little Valley Subdivision from Traverse Ridge Special Service District (TRSSD)

- 6.1 City Manager David Dobbins showed boundaries for the Traverse Ridge Special Service District (TRSSD), explained that no TRSSD services were provided within the Little Valley Subdivision, and said the Little Valley Subdivision had asked to be withdrawn from the TRSSD. Mr. Dobbins confirmed the TRSSD Board supported the withdrawal request.
- 6.2 Councilmember T. Lowery moved to approve Resolution #23-39. Councilmember Roberts seconded the motion.
- 6.3 A roll call vote was taken. The motion passed unanimously.

WHEREAS, The City Council reviews and adopts policies and procedures to assist in the efficient utilization of City resources and the fair and uniform application of requirements and benefits to City employees; and

WHEREAS, The City Council has reviewed Policy 1020 of the Personnel Policies and Procedures Manual and has determined a need to amend the Definitions Policy; and

WHEREAS, The City Council believes this amendment is in the best interest of the employees of Draper City.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF DRAPER CITY, STATE OF UTAH, AS FOLLOWS:

Section 1. Amendment. The Draper City Council does hereby adopt the amendments to Policy 1020 of the Personnel Policies and Procedures Manual as attached hereto as Exhibit “A.”

Section 2. Severability. If any section, part or provision of this Resolution is held invalid or unenforceable, such invalidity or unenforceability shall not affect any other portion of this Resolution, and all sections, parts and provisions of this Resolution shall be severable.

EXHIBIT “A”

Section 1020 – Definitions (Amended 08/15/2023)

For the purpose of the Policies and Procedures contained in this manual, certain words and phrases used herein shall be defined as follows:

Anniversary Date: The date on which an employee begins employment in their current position.

City: Draper City, Utah.

Date of Hire: The date on which an employee begins employment with the city.

Elected Officials: The city’s elected officials are designated as part-time employees of Draper City. Elected officials serve at the discretion of the citizens of Draper. They receive compensation and benefits based upon laws of the State of Utah and ordinances and policies adopted by Draper City.

Employee, Appointed: Any employee appointed by the mayor, city manager, or other person or body with the power to appoint employees. These employees serve in full-time, at-will positions that are exempt from the Fair Labor Standards Act (FLSA) overtime requirements. These employees may receive all standard city benefits, effective on the date of program eligibility.

Employee, At-Will: Any person that does not have the protections under Utah Code §10-3-1105(1)(a).

Employee, Exempt: Employees primarily performing work that is exempt from or not subject to the overtime provisions of the Fair Labor Standards Act (FLSA). Exempt employees are generally paid a salary.

Employee, Full-time: Any employee working for the city on a continuous basis who is regularly assigned to work ≥ 30 hours per workweek.

Employee, Nonexempt: Employees primarily performing work that is subject to the overtime provisions of the Fair Labor Standards Act (FLSA). Nonexempt employees are generally paid on an hourly basis.

Employee, Part-time: Any employee working for the city on a continuous basis who is regularly assigned to work < 30 hours per workweek. Part-time employees shall not work more than 1,500 hours during a calendar year. In accordance with the Patient Protection and Affordable Care Act (PPACA), part-time employees are not eligible to receive benefits unless otherwise required by law. Part-time employees are at-will employees.

Employee, Probationary: Any employee working for the city either full-time or part-time but not yet having successfully completed a Probationary Employment Period. Probationary employees are at-will employees.

Employee, Rehire: A former employee who had a an acceptable performance record at time of separation, was employed at least 12 continuous months, and returned as an employee within 12 months of separation, shall have their date of hire as a full-time employee reinstated for purposes of determining years of service, accruing benefits, and eligibility for benefit plan participation.

Employee, Seasonal: Any employee hired for seasonal work of less than six continuous months. Seasonal employees are not eligible to receive benefits unless otherwise required by law. They are at-will employees.

Employee, Temporary: Any employee hired for a defined project or a limited timeframe not to exceed 12 months. Temporary employees are not eligible to receive benefits unless otherwise required by law. They are at-will employees.

Level or Band: A group of positions sufficiently alike in duties, authority and responsibility to justify the same position title, qualifications, and the schedule of pay to all positions in the group.

Patient Protection and Affordability Care Act (PPACA) Initial Measurement Period: The initial measurement period for part-time employees begins on their date of hire and ends after they have completed 12 months of employment. The administrative period begins after the initial measurement period and will be one month. If the employee qualifies for medical insurance coverage, the coverage will begin on the new benefit year, i.e. July 1, following the administrative period.

Personnel Administrator: The City Manager or as delegated to the Human Resources Director or other designee.

Separation: When an employee leaves service of the city for any reason, whether voluntary or involuntary.

Service Date: The original date of hire as a full-time employee for purposes of accruing benefits and determining years of service. This date is reflective when part-time, seasonal or temporary employee becomes a permanent full-time employee. This service date is the first day worked as a full-time employee.

Volunteers: Any person who donates service without pay or any other compensation, except community service workers. Volunteers are not considered employees.

Re: Resolution 23-45 Approving and Extending Proclamation of Local Emergency 23-02

Comments:

On August 3, 2023 a localized storm cell dumped approximately 2" of rain on areas of Draper in under two hours. The volume of rain in such a short period of time damaged city streets and infrastructure, including the storm water system. Mayor Walker declared a state of emergency in order to marshal resources from the city, Salt Lake County, the state and federal governments.

Utah Code 52-2a-208(6) requires city council approval to extend the state of emergency beyond thirty days. City departments are still evaluating the extent of damages and formulating a plan on how to repair damage, including assessing the financial, work force and materials required to complete repairs.

Damage to the storm water system in parts of the city necessitates immediate repairs.

RESOLUTION NO. 23-45

A RESOLUTION OF THE DRAPER CITY COUNCIL
APPROVING AND EXTENDING
PROCLAMATION OF LOCAL EMERGENCY NO. 2 OF 2023
CONCERNING DAMAGE CAUSED BY TORRENTIAL RAIN

WHEREAS, on August 3, 2023, Mayor Troy K. Walker, in his capacity as Draper City's chief executive officer, issued a Proclamation of Local Emergency No. 2 of 2023 ("Proclamation") declaring a state of local emergency in the City concerning damage to roads and city infrastructure caused by flooding due to torrential rains (the "Rain Storm"), as authorized by the Disaster Response and Recovery Act, UTAH CODE ANN. 53-2a-201 *et seq.* (the "Act"); and

WHEREAS, UTAH CODE ANN. 53-2a-208(6), provides that a local emergency shall not be continued or renewed beyond the initial 30 days without consent of the governing body of the jurisdiction subject to the declaration; and

WHEREAS, because (a) the Proclamation will expire on September 2, 2023, absent action of the City's governing body (the "Council") to extend it; (b) city roads and infrastructure remain unrepairs; (c) the danger of additional damage to city roads, infrastructure, and private property occurring should additional rain fall; and (d) plans are still being developed to complete the necessary repairs to city roads and infrastructure, the City Council met in regular session on August 15, 2023, to consider, among other things, approving and ratifying the Proclamation and extending its duration until such time as the Proclamation is terminated; and

WHEREAS, after due consideration, the Council has determined that acting to so approve, ratify and extend the duration of the Proclamation is in the best interest of the health, safety and welfare of the City's residents;

PROCLAMATION OF LOCAL EMERGENCY

WHEREAS, Draper City ("City") is a political subdivision of the state of Utah;

WHEREAS, the City's Mayor is the chief executive officer of the City and has authority pursuant to Utah Code Ann. §§ 53-2a-205 and 208 to declare a local emergency;

WHEREAS, the Mayor may declare by proclamation a state of emergency if (s)he finds that (a) a disaster has occurred or the occurrence or threat of a disaster is imminent in an area of the City; and (b) the City requires additional assistance to supplement the response and recovery efforts of the City;

WHEREAS, a disaster is defined as "an event that causes, or threatens to cause loss of life, human suffering, public or private property damage, or economic or social disruption resulting from attack, internal disturbance, natural phenomena, or technological hazard; and requires resources that are beyond the scope of local agencies in routine responses to emergencies and accidents and may be of a magnitude or involve unusual circumstances that require response by government, not-for-profit or private entities." Utah Code Ann. § 53-2a-102(5). "Natural phenomena" includes any earthquake, tornado, storm, flood, landslide, avalanche, forest or range fire, or drought Utah Code Ann. § 53-2a-102(14).

WHEREAS, conditions of the following nature exist or pose an imminent threat in the City or an area of the City which require emergency assistance by the City to protect lives and property within the City; or to avoid or reduce the threat of a disaster;

Widespread Damage Injury or Loss of Life or Property Social Disruption

NOW, THEREFORE, THE DRAPER CITY MAYOR MAKES THE FOLLOWING FINDINGS AND PROCLAMATION DECLARING A LOCAL EMERGENCY:

1. A local emergency is hereby declared with respect to the area and conditions specified above based on the findings that (a) a disaster has occurred or the occurrence or threat of a disaster is imminent in an area of the City; and (b) the City requires additional assistance to supplement the response and recovery efforts of the City.
2. This Proclamation shall take effect immediately and will be ongoing for thirty (30) days unless an extension is authorized by resolution of the Draper City Council or is otherwise terminated.
3. The emergency powers and operations of Draper City are hereby invoked and Draper City's personnel and resources are ordered and authorized to perform all functions authorized by federal, state, and local law to address this local emergency.
4. Draper City is authorized to request all assistance available with respect to this local emergency from all federal, state, and local sources and is authorized to activate all applicable mutual aid agreements.
5. The Draper City Council will be notified of this Proclamation and this Proclamation shall be filed promptly with the City Recorder and will be delivered to the State of Utah and Salt Lake County and will be disseminated to local media.

Boondocks Food & Fun - Draper LLC has met both the 300' and 200' distance requirements.



- Liquor liability insurance.

Boondocks Food & Fun - Draper LLC possesses a valid, issued business license.

The findings are as follows:

6-4-040 (B) (2) (a) of the Draper City Municipal Code states the following:

A n **on-premises banquet license**, reception center, on- premises beer retailer license, or bar establishment license shall not be granted to a business located within six hundred feet (600') of any community location as measured from the nearest patron entrance of the proposed outlet by following the shortest route of ordinary pedestrian travel to the property boundary of the community location or within two hundred feet (200') of the proposed outlet measured in a straight line from the nearest patron entrance of the proposed outlet to the nearest property boundary of the community location.

Boondocks Food & Fun - Draper LLC has met both the 600' and 200' distance requirements.

Per Draper City Municipal Code 6-4-050 (B) (4) (d), there is no limitation on the amount of on-premises banquet licenses granted by the city.



Comments:

Boondocks Food & Fun - Draper LLC located at 75 E Southfork Dr is seeking Local Consent for an On Premises Beer Retailer License. They have provided the following:

- A floor plan showing where the alcohol is to be stored, served, and consumed.
- A bond payable to the Department of Alcoholic Beverage Services.
- The results of a background check performed on the food and beverage manager.
- Copy of sales tax license.
- Liquor liability insurance.

Boondocks Food & Fun - Draper LLC possesses a valid, issued business license.

The findings are as follows:

6-4-040 (B) (2) (a) of the Draper City Municipal Code states the following:

An on-premises banquet license, reception center, **on- premises beer retailer license**, or bar establishment license shall not be granted to a business located within six hundred feet (600') of any community location as measured from the nearest patron entrance of the proposed outlet by following the shortest route of ordinary pedestrian travel to the property boundary of the community location or within two hundred feet (200') of the proposed outlet measured in a straight line from the nearest patron entrance of the proposed outlet to the nearest property boundary of the community location.

Boondocks Food & Fun - Draper LLC has met both the 600' and 200' distance requirements.

Per Draper City Municipal Code 6-4-050 (B) (3) (d), "the total number of on-

premises beer retailer licenses ... shall not exceed one per each four thousand (4,000) population of the City based on the latest population estimate provided by the State of Utah Department of Workforce Services."

As of 2020, the Department of Workforce Services estimates Draper City's population to be 51,017. This permits 12 on-premises beer retailer licenses to be issued. Draper City currently has two on-premises beer retailer licenses issued.


