


My BeUTAHful Community Student Art Competition

Contract: Memorandum of Agreement Regarding Joint Participation in Transit Service and Facilities (Park City Municipal Corporation and High Valley Transit)



Background

- 2011 ILA between Summit County, Park City (PC) and UTA to fund and operate Park City Connect (PCC)
- 2020 ILA between Park City and UTA to collaborate in procurement of battery electric buses, charging equipment and stations for PCC. UTA/PC awarded FTA No/Low grant for electric buses. Secured funding (\$500,000) from Rocky Mountain Power as a local match. Park City was also awarded federal section 5311 grant funds for additional electric buses.
- 2021 ILA between Park City and High Valley Transit (HVT) to recognize HVT as successor in interest to the 2011 ILA.
- 2022 MOU between UTA and HVT to transfer operating responsibilities for PCC to HVT and to end all obligations under the 2011 ILA except for the amounts owed between the parties



2023 MOA is needed to provide clarity regarding:

- Remaining amounts owed between the Parties under the previous ILAs, MOA's and MOU's.
- Responsibility for the current procurement of replacement vehicles, construction of charging equipment and coordination of corresponding grants received by the parties.

To Park City Municipal Corp	\$942,989	Vehicle Replacement Account, Rocky Mountain Power Grant
To High Valley Transit	\$524,130	Vehicle Replacement Account
To UTA from Park City	\$835,607	Reimbursement from No/Low Grant funding for design and construction of charging station at Salt Lake Central
To UTA from High Valley Transit	\$131,795	Operating cost contribution owed to UTA under 2011 ILA



Other obligations due to 2020 ILA to procure battery electric buses (BEB) and corresponding charging equipment:

- UTA will award and manage the design and construction contract for overhead charging station for BEBs to be used on Park City Connect at Kimball Junction
- Once completed, the charging station will be turned over to HVT
- PC will reimburse UTA for the full cost of design and construction of the Kimball Junction Project from the grant and local matching funds


- Continuous program

Importance of bus service

- More than half of UTA ridership is attributed to bus modes
- Bus riders are more likely to:
 - Have lower household income
 - Identify as minority/non-white
 - Use transit
 - more frequently
 - for non-work trips
 - as primary mode of transport
 - throughout the pandemic




Benefits of improved speed and reliability


- Improved rider and operator experience
- Expanded ridership on existing routes
- Alignment with local and regional goals
- Efficiency: cost, time, labor, energy...
- Safety for all modes of transportation





BSRP Initial study routes










BSRP Toolkit

Funding and implementation

- \$100,000 budget annually
- Opportunities for grants and partner funding, depending on projects
- Projects are small but can be packaged together.
- In-house design
- Test short-term, low-cost, scalable
 - "Tactical urbanism"






Work to date

- Bus "Ride-Alongs"





Quick, Collaborative Action

- Coordination meetings initiated April 2023
- Partners: Resorts; SL County;
 Visit Salt Lake; Town of Alta;
 UDOT
- Innovative solutions in process
 - Alternative transport for resort employees
 - Hotel guest shuttle collaborative solution
- Increased travel capacity





Ski Service - This Season's Outlook

■ 2023 season:

 14% reduction in ridership (during record snowfall, driver shortage)

■ 2024 season:

- Increased ridership capacity (due to employee shuttles)
- Surge service
- Larger (newer) buses continue





Proposed 2023-2027 Capital Plan Amendment and 2023 Capital Budget Amendment for the TRAX Daybreak Station Project



Summary of Requests

Two-Part Request

- Part 1- Amendment to 2023-2027 Five-Year Capital Plan
 - Adds one new project to plan:
 - MSP300- New Daybreak TRAX Station
 - Adds \$6.5 M to five-year plan. All funds will be reimbursed by external sources.
 - No impact to UTA reserves
 - Next step is to take a Resolution to Local Advisory Council to amend 2023-2027 Five-Year Capital Plan
- Part 2- Increase Budget Authority for 2023 in response to modification of five-year plan
 - Next step is to consult with Local Advisory Council on a 2023 Capital Budget Amendment



Part 1- 2023-2027 Five-Year Capital Plan Amendment

- New capital projects must be approved by the Local Advisory Council and Board of Trustees.
- A resolution amending the 2023-2027 Five-Year Capital Plan, to include the new project, will be presented to the Local Advisory Council for approval and subsequently to the Board of Trustees for adoption.



Project Being Added

- MSP300- New Daybreak TRAX Station
 - Funded through external partner sources
 - Will serve the area where the new baseball field is being constructed
 - Will add funds to 2023-2025 plan years
 - 2023 will add funds to go from 30% design to 100% design
 - 2024 & 2025 funds are for construction

All added funds are from external sources resulting in no impact on UTA's reserves



Part 2- 2023 Capital Budget Amendment

- In conjunction with the 5-Year Capital Plan amendment, an amendment to the 2023 Capital Budget is also needed to provide budget authority commensurate with the previously described actions.
- Budget amendments require consultation with the Local Advisory Council and subsequent approval by the Board of Trustees through a board resolution.



2023 Capital Budget Amendment Request

 Overall will increase the 2023 budget authority by \$500,000 to accommodate the new project addition
