PARKS, TRAILS, AND RECREATION COMMITTEE MINUTES

- 1. **Approval of 5-3-2023 Minutes** Motion by Josh Christensen, seconded by Doug Ovard, to approve the minutes. Motion passed unanimously.
- 2. **Trails & Open Space Erosion** Greg Hilbig reviewed the status of recent erosion issues on trails and in public open space, and reviewed photos of recent repairs and ongoing issues. City to hire professional consultants to provide direction on best restoration practices for the large landslide at Hidden Canyon Estates. Committee request opportunity to review any proposed restoration/clean up plan.
- Zooropa Trail Reconstruction Jamie Pogue asked for the committee's input regarding keeping the old trail alignment open for use. The committee did not want to make a recommendation until the new trail has been constructed. It was suggested that the trail reconstruction consider keeping the upper berm and constructing a smaller lower berm.

4. Committee/Staff reports

Committee mentioned that the wall ride area of upper Rush has some drainage issues and needs attention.

Staff reported that there have been some delays in finalizing the design for Deer Ridge Trailhead, but hope to have it out to bid this month. Staff is also looking at installing a temporary trail around the construction site.

Committee has concerns with several restroom stalls at Peak View Trailhead being closed, and issues with water being off. Suggestion to replace yard hydrant with self-closing yard hydrant that is easier to turn on and off.

Committee is interested in having a bike only trail connection between Eagle Ridge Trailhead to the top of Rattle n' Hum Trail. Staff to look into potential alignments.

It was decided to cancel the July meeting. Next meeting will be on August 2nd.

5. **Adjournment** - Motion by Jamie Pogue, seconded by Doug Ovard to adjourn the meeting. Motion passed unanimously.
