

**Minutes of the North Logan City
Redevelopment Agency (RDA) Meeting
Held on June 7, 2023
At the North Logan City Library, North Logan, Utah**

Emily Schmidt made a motion to convene to the meeting of the North Logan Redevelopment Agency. Buzzy Mullahkhel seconded the motion. A vote was called and the motion passed unanimously with Buzzy Mullahkhel, Craig Humphreys and Emily Schmidt voting in favor.

The meeting was called to order by Mayor Lyndsay Peterson at 6:58 p.m.

Adoption of Agenda

Emily Schmidt made a motion to adopt the agenda. Craig Humphreys seconded the motion. A vote was called and the motion passed unanimously with Buzzy Mullahkhel, Craig Humphreys and Emily Schmidt voting in favor.

New Business

(Item #3 from City Council Meeting Agenda) 6:45 Convene as the Redevelopment Agency to hold Public Hearings to receive public input on: 1) a proposed revision to the FY2023 RDA Budget, and 2) a proposed FY2024 RDA Budget. Following the public hearings, approval of resolutions may be considered to adopt proposed changes to the FY2023 RDA Budget and to adopt the FY2024 RDA Budget.

Emily Schmidt made a motion to adjourn the North Logan Redevelopment Agency meeting and return to the regular City Council meeting. Buzzy Mullahkhel seconded the motion. A vote was called and the motion passed unanimously with Buzzy Mullahkhel, Craig Humphreys and Emily Schmidt voting in favor.
