Notice of Public Hearing

The Washington County Planning Commission will be holding a Public Hearing regarding a zone change and amended plat in the Brookside Summer Homes subdivision. The applicant is requesting to partially amend and extend the Brookside Summer Homes Subdivision. Several parcels are being reconfigured as part of this change. Brookside Summer Homes is currently zoned RE-40 (Residential Estate 40,000 sq ft minimum lot size). The proposed amendment will extend the subdivision into a portion of parcel 7129-A-1-NW, which is zoned OST-20 (Open Space Transition 20 acre minimum lot size), the zoning for this parcel will remain unchanged. Several parcels within the Brookside Summer Homes subdivision will have property added to their current boundaries as part of this amendment; BSH-1-A-NW, BSH-3-A-1-A-NW, BSH-54-A-NW, BSH-56-NW, and BSH-57-NW. The zoning for these parcels within the Brookside Summer Homes subdivision will remain as RE-40 (Residential Estate 40,000 sq ft minimum lot size). Parcel 7129-B-NW is being eliminated, which was a non-conforming lot due to acreage requirements of the OST-20 zone.

Parcel BSH-2-A-NW is the subject parcel which triggered this application. This parcel will extend outside of the existing Brookside Summer Homes subdivision. This parcel will be zoned A-5 (Agricultural 5-acre minimum lot size). A new parcel totaling 6.09 acres will be created on the other side of Wells Fargo Rd, which will require an advanced septic system, water service from Veyo Water Company, and will be zoned A-5 (Agricultural 5-acre minimum lot size).

The applicant has agreed to dedicate a portion of Wells Fargo Rd which fronts the amended area.
