TIME AGENDA ITEM AND SUMMARY

:00 1. WELCOME

1.1. Call to Order (5:50)

Chair Ron Tolman called the meeting to order, and Off-highway Vehicle (OHV) Grant Administrator Rachel Toker recorded the minutes. Ms. Toker also took attendance of the council members present. With a quorum of council members in attendance, the meeting proceeded with its agenda.

1.2. Attendance and Introductions (6:45)

Chair Tolman asked everyone in attendance to introduce themselves. Council members provided their names and affiliations for the record.

1.3. Approval of April 21, 2023, Meeting Minutes (8:40)

Chair Tolman presented the minutes of the April 21, 2023, OHV Advisory Council meeting and requested their approval as presented.

BRODY JOHNSON MOVED TO APPROVE THE MEETING MINUTES FROM THE APRIL 21, 2023 OHV ADVISORY COUNCIL MEETING.

ERIC NELSON SECONDED THE MOTION, AND IT CARRIED UNANIMOUSLY.

9:20 2. PUBLIC COMMENT PERIOD

Chair Tolman opened the floor to public comments, welcoming input from both in-person attendees and online participants. It was agreed by Ms. Toker and Chair Tolman to allocate time for individuals present to address their respective grant applications at the time of review.

10:30 3. REVIEW & APPROVAL OF COORDINATION FORM FOR ACCESS PROTECTION APPLICANTS

Chair Tolman turned the time over to Shane Stroud from the Attorney General's Office, who provided a presentation on the coordination process between the Division and the Public Lands Policy Coordination Office (PLPCO) for Access Protection applicants. This form facilitates the grant's ability to ensure that access protection projects comply with legal requirements.

Council member Laura Ault spoke in support of the created form, explaining that it streamlines the process. She noted that previously, applicants were contacting various employees within PLPCO, but this form ensures consistency with a single point of contact.

Having no further questions, Chair Tolman sought a motion.

FRED CHRISTENSEN MOVED TO APPROVE THE COORDINATION FORM FOR ACCESS PROTECTION APPLICANTS. SCOTT WHEELER SECONDED THE MOTION, AND IT CARRIED UNANIMOUSLY.

17:55 4. REQUIRED APPLICANT PRESENTATION

4.1. Navajo Road OHV Improvement Project (18:35)

Leslie Fonger from Greater Zion presented the project application, explaining its connection to St. George and the Red Cliffs Desert Reserve. She also highlighted the necessity of this improvement due to the lack of a staging area for OHV users.

Advisory council member Scott Wheeler voiced concerns regarding the project, leading to a discussion. OHV Program Manager Chase Pili intervened, allowing each participant an opportunity to express their views.

Chair Tolman mentioned that scoring for this and the following project will occur during the grant review.

4.2. Toquerville Falls Road Improvement Project (41:45)

Jeff Beiber from Desert Roads and Trails Society presented his project, outlining the necessary road improvements. He emphasized the importance of these improvements for search and rescue (SAR) operations, as the current road conditions hinder their ability to assist people in need.

Council member Eric Nelson inquired about the classification of the road. Ms. Fonger confirmed that the road is designated as a Class B road. The council then asked Mr. Stroud whether this grant could legally fund projects involving County B roads. Due to this uncertainty, the council requested that Mr. Stroud conduct further research on the matter. Subsequently, the council decided to proceed with scoring on both this issue and the previous application under the assumption that the grant could legally fund improvements to County B roads.

The council did not have a unanimous vote and both grants received a roll-called vote.

Both grants were recommended for funding contingent on Mr. Stroud's findings.

1:38:35 5. BEGIN GRANT REVIEW FOR SUMMER FY24

Chair Tolman yielded the floor to Ms. Toker, who provided a concise overview of the 40 grants. She highlighted that there is a total of \$6.0 million available for grant awards for the Summer and Spring FY24 cycle. Ms. Toker also stated that the remaining balance will be available for the next cycle. The total funding requested by applicants amounted to approximately \$3.4 million. She emphasized the importance of ensuring that the percentages of funding awarded versus the amounts requested align appropriately.

The following discussions and votes are provided for applications where there were discussions or dissenting opinions. In cases where no conversation occurred and unanimous votes were cast, it can be assumed that funding was approved.

1:40:00 Application #1 - OHV Refresh for Grand County Search and Rescue

The council discussed how the SAR calls relate to an applicant's matching funds. This discussion pertained to all SAR applications.

1:49:30 Application #2 - Piute County SAR

Council member Fred Christensen expressed his support for the application. He stated that he spoke with the applicant and made a recommendation for adding tracks to the project's request.

FRED CHRISTENSEN MADE A MOTION TO INCREASE THE PROJECT FUNDING BY \$8,000. BRODY JOHNSON SECONDED THE MOTION, AND IT CARRIED UNANIMOUSLY.

2:12:25 Application #7 - Kane County Roads and Trails Access Protection Initiative

The council felt that buying two top-of-the-line machines for inventorying trails was not the best use of funding. The council discussed decreasing the funding and allotting \$60,000 to help purchase two mid-level machines.

KIRK CHESTER MADE A MOTION TO DECREASE THE FUNDING AMOUNT TO \$60,000 AND DECREASE THEIR TOTAL PROJECT COST TO \$68,200. SHERIFF CURTIS SECONDED THE MOTION, AND IT CARRIED UNANIMOUSLY.

2:34:45 Application #10 - Wayne County OHV Response

Mr. Wheeler expressed his conversation with the applicant, he raised concerns about the low cost of six bikes. The applicant was apprehensive about overspending. Mr. Wheeler also raised concerns about whether the machines would be powerful enough for their needs.

ERIC NELSON MADE A MOTION TO INCREASE THE FUNDING AMOUNT BY \$12,000 ALLOWING THE APPLICANT TO PURCHASE TWO HIGHER-END BIKES TO MEET THEIR NEEDS. SCOTT WHEELER SECONDED THE MOTION, AND IT CARRIED UNANIMOUSLY.

2:42:30 6. LUNCH

At this time, the OHV Advisory Council took a 20-minute lunch break. The recorders were taken offline at this time.

3:05:45 7. CONTINUE GRANT REVIEW

After taking lunch the Council proceeded to review the grant proposals beginning with the applicants in the room. The council started with application #32.

3:18:00 Application #23 - Uintah County Stop Vandalism

Mike Cook with Uintah County fielded questions regarding the application. Mr. Christensen was worried about the funds sitting in an account until an issue arose. He also mentioned that the Paiute Trail Committee has an award for vandalism and has only awarded someone one-time in a two-year time period.

4:47:15 Application #31 - Uintah County Stop Vandalism

The council discussed concerns regarding the procurement of single-use medical supplies. They also expressed the belief that there might be alternative funding sources accessible to the applicant. As a result, the council requested council member Sheriff Curtis to collaborate with the county's sheriff in assisting the applicant in exploring alternative grant opportunities for SAR purposes.

5:16:55 Application #40 - DWR Snow Operation Training

Sheriff Curtis expressed concerns that it seemed the applicant had used Utah County's SAR calls to bolster their SAR statistics. There were also concerns about the intended use of the machines, particularly whether they would be deployed for SAR calls. Furthermore, it was noted that the applicant had not contacted the leadership of the agencies that provided letters of support.

5:23:25 8. MOTION TO APPROVE RECOMMENDED OHVR GRANTS FOR SUMMER FY24

Out of the **40** Off-Highway Vehicle Recreation (OHVR) Grants received, the OHV Advisory Council has recommended **37** grants for funding in the FY24 Q1 - Summer period.

Out of those 37 recommended grants, two (2) projects were recommended for funding contingent on the findings of Mr. Stroud.

1. Why are you interested in filling the specific position?

I would like to help represent the interests of 4-wheel drive enthusiasts throughout the state of Utah, as well as those many visiting from around the country. I believe that I have a seasoned perspective on 4x4 and Off Highway Vehicle issues and needs.

2. What specific qualifications could you bring to the Council?

I am a life-long "Jeeper" and all-around 4-wheel drive enthusiast, owning 4x4 vehicles from several different manufacturers. I have been involved in the Utah 4-wheel drive community in some fashion since the early 90s. I have an engineering background and try to be objective, thoughtful and methodical in the way I approach new challenges, information, and issues.

I have a passion for 4-wheel drive vehicles that began as a little kid. I bugged my dad until he bought a Chevy Blazer when I was 8, and later he bought a Bronco. As a teen I read a lot of 4-wheel drive magazines and learned about the events and projects that organized 4-wheel drive groups around the country were involved with. I recall my friend's dad telling me about the Moab Easter Jeep Safari and I couldn't wait to attend. My friends and I went 4-wheeling whenever we could.

As I entered my 20s, I decided to get involved with the local clubs and the state association, the Utah 4 Wheel Drive Association (U4WDA). I wanted the state group to put on some of the cool events that I knew other states around the region were doing. I helped organize quarterly trail rides in addition to the annual summer and winter conventions. I served for 6 years as the President, and later as "Duke of Special Projects", during which time I also served on the board of the Blue Ribbon Coalition.

I was part of an email group in the 90s-2000s called Jeep-SLC. Members of that group made up most of the BOD of U4WDA, one of them started Utah Rockcrawling and Offroad Challenge (UROC) competition rock crawling, and several members of that group served as presidents of U4WDA, have served on the OHV Advisory Council, and in recent years, started the Salt Lake Off Road Expo (SLOREX).

Over the last 8 years I have helped organize and build a team of skilled volunteers committed to the safe recovery of off-road vehicles (fullsize and ATV/SxS), going where the tow companies prefer not to. Initially approaching 300 volunteers in a free-for-all Facebook based format, our leadership board installed membership requirements and training, and the membership dropped to 30 committed members, recently growing to 40. The Utah Off Road Recovery Team (Team) typically sends 2 or more volunteers on each recovery to locations all over northern Utah. (Moab and the St George area have several companies that offer these services). Davis County dispatch has our group on speed dial, and we are working towards having MOU with other county dispatch services. During the first 90 days of 2023, the Team had just shy of 100 recoveries. All services are free of charge, though the group accepts donations.

As a licensed mechanical engineer, I manage multi-discipline projects for an engineering firm in the mineral processing, petroleum refining and power production and distribution sectors. I manage engineers and designers and work closely with our clients to understand and help them meet their business objectives.

3. What would be your primary objective in serving on the Council?

My primary objective would be to fairly represent the specific needs of 4-wheel drive enthusiasts and also do my part to help fulfil the duties of the OHV Advisory Council at large, including grant review, helping with the state's OHV program, and coordinating with the different stakeholders in the OHV community itself, including lawmakers, land managers, users, vendors and non-OHV users.

4. What is your background in dealing with current four-wheel drive issues?

I have experience in dealing with different kinds of 4-wheel drive issues, from laws and regulations to education to access.

In the late 90s, several of us that were active in Jeep-SLC and U4WDA set out to change the Utah lift law, which was poorly written and hard to understand. We used the structure of U4WDA to organize members throughout Utah to work with their elected Utah House Representatives and Senators. Through a lot of hard work and persistence, the law passed 72-0-3 in the house and 25-2-2 in the Senate and was signed into law in Feb 2001.

I served on the board of the Blue Ribbon Coalition, a national group organized and committed to preserving OHV access to public lands. I try to stay involved and informed and provide review and comment on FS and BLM management plans.

I help lead and tailgun organized trail rides several times a year to assist and help educate drivers. I've been leading and gunning trails at Jeep Safari since the mid-90s, U4 trail rides since the 90s, Vernal Rock Rally since it started, Trail Hero for a few years, Winter 4x4 Jam for a few years, Labor Day Campout and RR4W Trail of the Month. I also work with several local clubs with their annual National Public Lands Day Projects.

Plus, I literally help weekly with the issues of people getting stuck off-road, whether it's dispatching a team or responding, and often both.

1. Why are you interested in filling this position?

My biggest concern is the continued loss over the years of OHV ridding opportunities and the threat of more losses. I have a passion for ridding off-road motorcycles and have had that from my youth. I also believe we as participants in any form of activity are responsible for maintaining it and without an organized investment of our time into any sport or activity we will by and by lose or be restricted in that opportunity.

2. What special qualifications do you feel you could bring to the council?

I spent several years participating in motocross and desert racing and somewhat less time in hill climb and trials events; while not participating currently as a competitor in these events I do enjoy being involved in these activities at a planning level and have a good understanding what it takes to organize events. I still have a zeal for riding single track and dual sport.

Over the years I have been involved with several off road motorized organizations the Sage Riders Motorcycle Club, CEMA, CCOHVA, UTMA, RWR and Blue Ribbon Coalition. I enjoy a broad range of recreational opportunities that Utah has to offer including non-motorized.

I have spent thousands of hours volunteering time to a multitude of different organizations and activities. Over the past 40 years many hundreds of hours have been spent working with lands access issues with the Price BLM field office and the Manti- La Sal Forest Service and Carbon and Emery Counties.

The BLM touted the project as very successful and made navigation of the area much friendlier and more responsible.

In 2008, as a volunteer, I help organize and produce a document which contained about 1800 georeferenced photographs depicting mans interaction with public lands and rating those interfaces in Carbon and Emery Counties. Typical of the document was photos showing roads, drill sites, mining activities and structures. This document contained several maps and comments along with the images and was submitted to The Price BLM field office and Carbon and Emery Counties for the purpose of evaluating expansion of wilderness lands.

I spent two years working with Emery County Lands Council on the transportation subcommittee. My responsibilities were to gather road and trail data, take photos and present this information to the full lands council for evaluation.

From about 2004 to 2006 I volunteered as an OHV trainer.

For several years I was member at large for the Carbon County Trails Committee, developing both motorized and non motorized routes.

To help preserve the motorized recreational opportunities that I have enjoyed in my life and interact with others that have the same concerns. - Meetings will be open to the public. The Chair will determine when and if members of the public will be permitted to speak in Council meetings.
