WHEREAS, the City Manager has prepared the proposed budget for the West Jordan Fairway Estates Special Service Recreation District for Fiscal Year 2014-2015 and has submitted the same to the District Board; and

WHEREAS, the District Board has completed the review of said budget; and

WHEREAS, the District Board desires to adopt the Tentative Budget to be submitted to the members of the District and the general public for review and comment; and

NOW, THEREFORE, BE IT RESOLVED BY THE WEST JORDAN FAIRWAY ESTATES SPECIAL SERVICE RECREATION DISTRICT BOARD:

SECTION 1. The District Board hereby adopts the Tentative Budget for the West Jordan Fairway Estates Special Service Recreation District for Fiscal Year 2014-2015 beginning July 1, 2014 and ending June 30, 2015.
