

2023 NOTICE OF GENERAL ELECTION

I, Jonathan T. Whittaker, Iron County Clerk, hereby give notice of the General Election that will be held on Tuesday, November 21, 2023.

General Election Information

Ballots will be mailed out to all eligible voters beginning October 31, 2023. Voters must be of legal voting age, a citizen of the United States, and a resident of the voting precinct in which they are registered. If you have re-registered by the below deadlines, we will mail you a ballot to your new address. Voters can check their registration status and view specific sample ballots online at www.vote.utah.gov, call (435) 477-8340 or email clerk.group@ironcounty.net

- If mailed, ballots must have **POSTAGE** and be **CLEARLY POSTMARKED ON OR BEFORE NOVEMBER 20, 2023.**
- Ballot Drop Boxes will be available at local cities and towns and on Election Day Vote Center locations.

Nov 20:	Mailed ballots must be <u>POSTMARKED</u>
Nov 21:	Election Day; see Election Day locations, date, and time below
Nov 21:	Unofficial Election results will be posted after 9:00 p.m.
Nov 28:	Post Election Audit at 2:00 pm in Clerks office
Dec 5:	Canvass of the Primary Election at 10:00 am
