Eagle Gate Campus, Murray – PN Program Update:

- On November 3, 2022, Nursing Advisory Peer Education Committee recommended Provisional Approval, as required by NLN CNEA, for pursuit of pre-accreditation status
- Following recent regulatory changes by the Idaho Board of Nursing, which exercises regulatory oversight over our branch campuses in Boise and Idaho Falls, ID - PN programs are now mandated to hold nursing accreditation.
- Modified accreditation strategy to ensure a streamlined approach across multiple campuses spanning different states: Actively pursuing accreditation from the Accreditation Commission for Education in Nursing (ACEN), which provider for better alignment of main and branch campuses
- Request: We kindly request the Committee to issue a revised provisional approval letter and NCLEX Code that we can include with ACEN Eligibility Application materials

Proposed Addition of PN Program at Layton and Provo Campuses

- Experienced a higher-than-anticipated demand from our healthcare clinical partners and the community in Murray.
- In light of the growing needs to increase the RN and PN workforce in Utah, we seek to extend the PN program to our branch campuses in Layton (Eagle Gate College) and Provo (Provo College).
- Propose: Commence student enrollments 2024, first cohorts expected to graduate in 2025. Enrollment: based on community demand.
- Program Directors will be hired for each campus
- Sufficient Clinical Affiliation Agreements ensuring non-displacement: 70+ Agreements
- Faculty – hire 2 months prior to course start
- Facilities:
 - Provo Campus: 40,000 SF, 9 Classrooms (2 are computer labs)
 - Layton Campus: 15,000 SF, 4 Classrooms (2 are computer labs)
 - Both Campuses: Simulation Labs (Adult/ICU Patients, Obstetrics/Pediatrics simulation), separate Debriefing Rooms, Control Rooms; Virtual Reality Laboratory; Active Learning Classroom; Learning Resource Center; Student & Faculty Lounge
- College plans to submit ABHES New Program Application and ACEN Eligibility Application
- Request: Provisional Approval from the Committee for ABHES and ACEN applications

Streamlined, Improved PN Curriculum – All Campuses

- Ensure an integrated skills lab, simulation, and clinical structure to ensure synthesis of content across subject areas
- The skills lab and clinical classes will take an integrated approach in the new curriculum, which will give faculty and students flexibility to synthesize a variety of important topics across the terms into nursing practice and application of content. This will also allow for greater flexibility in clinical placements.
- Transition from a clock hour structure to a credit hour structure
- Give students flexibility through an intentionally blended curriculum design
- Incorporates transition to practice classes across the final semester that will help the student focus on preparation for the NCLEX and entering the workforce as a licensed professional nurse.
