AMENDMENT TWO
of the
SUBRECIPIENT AGREEMENT FOR THE CONDUCT OF A
COMMUNITY DEVELOPMENT PROJECT (or PROJECTS)
between
SALT LAKE COUNTY
and
GREATER SALT LAKE MUNICIPAL SERVICES DISTRICT

THIS AMENDMENT TWO (“Amendment”), is entered into and shall be effective as of the 1st day of September 2023, by and between Salt Lake County ("County"), and Greater Salt Lake Municipal Services District, ("Subrecipient"). DUNS Number: 081524443. County and Subrecipient may be referred to jointly as the “Parties” and individually as a “Party.”

RECITALS

- A. The Parties entered into the above referenced agreement effective as of July 1, 2021, (“Agreement”), which Agreement is identified as Salt Lake County Contract No. HCD21114CH CDBG Program Year 47, and has a Period of Performance beginning on July 1, 2021, and ending on June 30, 2023, and a contract expiration date of August 31, 2023;
- B. The Agreement permits written changes to be made to the Agreement upon the mutual consent of the Parties; and
- C. It has been determined by the Parties that certain provisions should be modified as hereinafter provided.

NOW THEREFORE, in consideration of the mutual covenants contained in the Agreement, and other good and valuable consideration the receipt and sufficiency of which are hereby acknowledged, the Parties intending to be legally bound, covenant and agree as follows:

1. Paragraph 4, entitled Period of Performance, is amended as follows: The Period of Performance of this Agreement shall be extended for sixteen (16) additional months. The Period of Performance terminates October 31st, 2023. The Agreement expiration date shall be December 31st, 2023.
2. All parts, paragraphs, attachments and other provisions of the Agreement and any prior amendments thereof not specifically modified by this Amendment shall be the same and

remain in full force and effect. If this Amendment is executed more recently than the expiration of the Period of Performance stated in the Agreement, then this Amendment shall relate back to and be effective from the last day of the previous Period of Performance.
