Mr. Justis mentioned this policy not only refers to activities in the school but also to field experiences. Mr. Frank Schofield mentioned the policy was drafted in collaboration with the Utah School Board Association and the state legal counsel, the policy meets all the statutory requirements.

Mr. Justis and Mr. Schofield made clarifications concerning training on seizure medication.

Dr. Steven Lucero and Dr. Jennifer Grewe asked about sending students with medication to school. Mr. Frank Schofield explained that statewide there have been issues where a child had severe allergic reactions to a medication that another student brings to school. This state guideline was implemented to remove from the ability of students to inadvertently expose another student to something that could cause them harm by having it administered in the office.
