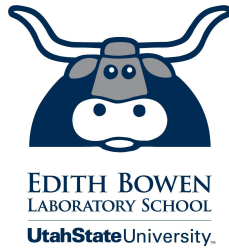

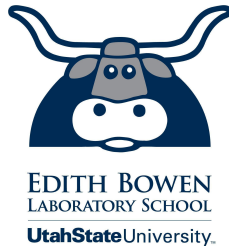

5. REGULATORY & STATUTORY COMPLIANCE

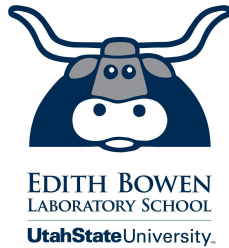
- a. Proposed anti-bullying policy revisions (discussion)

During the meeting, Mr. Justis presented a proposed policy revision to address the increasing emphasis on bullying from state leadership. He noted that the state is ramping up compliance and requesting policies to be sent annually. In light of this, he compared our current anti-bullying policy with the state model and found that our current policy may not be compliant.

The proposed policy includes more robust definitions and is a reiteration of the state law. Mr. Justis suggested that closer attention be paid to employee training to ensure compliance. He also suggested sending the policy to parents, teachers, and staff for review and feedback. He also noted that in practice, responses to bullying incidents are made within 24 hours.

During the discussion, it was suggested to use less criminalized language when addressing children. Mr. Justis agreed to make the changes and also agreed to bring any parent and employee feedback to the governing board meeting in a couple of months.

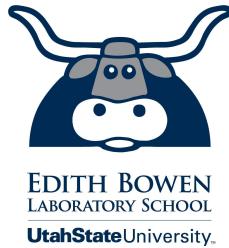
6. SCHOOL REPORTS

a. School report card

Dr. Reina presented the report card which was recently released by the state. The report card covers various areas, and as the primary grades are no longer given, growth and achievement are focused on instead. The first category of the report card is achievement, which primarily examines our RISE data. Overall, we did exemplary in this area. The second category is growth, which takes student growth percentiles, targets, and averages into account. Our students showed tremendous growth, which is fantastic to see.

However, when it comes to English learner progress, we are unable to calculate it due to having a small population. There isn't any information on self-reported indicators either, as we are still trying to determine what we can measure to represent our school. The data shows that we improved in every aspect of our overall report card. Our achievement points went up from 36 to 41, and our growth points went from 40 to 43. The overall growth percentage rose from 17 to 21, indicating that we have made significant improvements.

i. School highlights

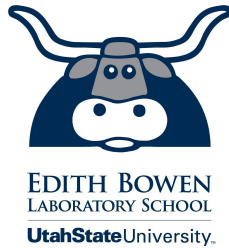
Principal's Report: Exciting School Activities

During his report, Mr. Justis shared some of the wonderful things that students and teachers are doing at the school. Second graders got to visit the Logan Fish Hatchery. They are currently learning about fish, including water systems and how they impact the growth and life cycle of animals. They observe fish hatching in the fall and try ice fishing in the winter to compare the differences in their bodies in different environments.

Mr. Lopez was given the opportunity to share his experience accompanying the fourth-graders on their field trip to the Bear River Massacre Site in Preston, ID. The trip featured three stations – one with Darren Perry, who presented the Shoshone perspective on the tragedy, highlighting the location of the massacre. Mr. Lopez's station was dedicated to watercoloring, encouraging students to connect with the place. Finally, at Mrs. Seifert's station, the students participated in an English language arts lesson on perspective taking. The students witnessed the massacre site firsthand and were able to draw connections between the material they had read and the Shoshone perspective presented by Darrin Perry. They gained a better understanding of the terrain and events that took place. This experience was an exceptional and powerful one for the students.

First-graders got to visit Mount Logan Middle School and scope out the Sundial installation. It's all about studying shadows and time, and it was a blast seeing it in action. Third-graders went to the canyon to study beaver habitats and even spotted a beaver in the wild!
