1. Approval of Minutes for September 2023 meeting:

Chase made a motion to approve the minutes with the corrections stated with a second from Scott. Voting was unanimous.

2. Discuss/Approve/Deny UFRA Comments and Business:

Riley: Winter fire school will be January 19-20. The survey came out asking what time to register and the vote was for 9 am. Online registration will open December 1st, 2023 at 9 am. You can review the classes beginning November before registering.

Fallen Fire Fighters Class: Everyone should have an email with all the information. October 28th will be a Flashover class. Riley will also see if he can get some instructors and set up a flashover class November 18th at the ropes and knots class Scott already has scheduled.

Regional class:

They have a new ventilation prop. There is one sitting at UFRA, ready to use around November. That would be a good prop to have.

Preston: He wanted to thank Huntington and Cleveland that were on the fire a few weeks ago. Everyone performed very well. It was a single wide trailer that was fully engulfed in flames when Law Enforcement and FireFighters got there.

Ben: Ben asked if there are any laws keeping them from carrying Narcan on the trucks. It was discussed that there is no law to prevent anyone from carrying Narcan. Just go to the Health Department and they will supply you with some.
