**AN ORDINANCE OF THE MILLCREEK COUNCIL ADOPTING
MILLCREEK'S 2024 REGULAR MEETINGS SCHEDULE**

WHEREAS, the Millcreek Council (the "*Council*") met in regular session on November 27, 2023, to consider, among other things, adopting Millcreek's 2024 regular meetings schedule; and

WHEREAS, Utah Code Ann. § 52-4-202(2) provides that any public body which holds regular meetings that are scheduled in advance over the course of a year shall give public notice at least once each year of its annual meeting schedule; and

WHEREAS, Utah Code Ann. § 10-3-502 provides that the council of each municipality shall, by ordinance, prescribe the time and place for holding its regular meetings which shall be held at least once each month.

NOW, THEREFORE, BE IT ORDAINED by the Council that the attached 2024 meetings schedule be adopted as the regular meetings schedule and the City Recorder is directed to give notice hereof as required by Utah Code Ann. § 52-4-202(2).

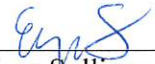
