List three (3) issues relating to planning and development you consider to be important that the City should address, and briefly outline your concern and position on each issue

1. Walkability: New projects and buildings should be inviting and welcoming not only to those who are using them, but to neighbors and passersby, too. We need to emphasize attractive storefronts and sidewalks that will make residents want to get out of their cars.

2. Traffic and transit: Traffic in Logan and throughout Cache Valley has been heavy and is only worsening. I believe that in if additional density, both business and residential, is focused around existing public transit routes, public transit use would increase.

3. Preserve the character of neighborhoods while encouraging business: While I believe that protecting single family neighborhoods is important, I also believe that growing business through attractive mixed use* (see below) What do you believe is the main role of the Planning Commission The Planning Commission's main role is to serve as an advisory board to the City Council on matters of development and zoning. The Planning Commissions serves an important role of offering citizen based and led input to the City Council.

Logan City Planning Commission

The Planning Commission consists of seven (7) members who are appointed by the Mayor with the advice and consent of the Municipal Council. Members must reside in Logan City.

The Commission meets on the 2nd & 4th Thursday of each month beginning at 5:30 p.m. until business concludes. A bus tour is generally provided at 4:30 (prior to each meeting) to tour the sites on the agenda. Members receive compensation of \$25 per meeting.

All necessary authorities pursuant to Chapter 9 of Title 10 Utah Code Annotated and Logan Municipal Code Chapter 2.40 have been conferred on the Planning Commission.

The Planning Commission is established as a non-political planning body for the purposes of both long range planning and current development review. The duties of the Planning Commission are generally as follows:

- General Plan review and recommendation to City Council
- Land Development Code review and recommendation to City Council
- Zoning Ordinance and Map review and recommendation to City Council
- Subdivision review and recommendation to City Council
- Conditional Use and Design Review Permitting
