

POLICY MEETING:

A. APPROVAL OF MINUTES for the June 8, 2022, HAAB Meeting

C. CONSIDERATION OF RESIDENTIAL HOUSING CODE VIOLATIONS:

1. Request for Consideration of Residential Housing Code Violations at 1229 East 1700 South, (Case No. HAZ2023-01446 Yingying Zhang), Council District 5 – Dan Marino

Appeal deficiency: Window opening in basement windows. Current openings6 are 15" W x 20" H and 15" W x 17.5" H. Full space openings are approximately 33"x 20".

Motion by Katie Sims to deny the appeal of deficient egress window size 15" W x 20" H and 15" W x 17.5" H openings and recommended installing casement windows and ladders to meet sill height. Second by Daniel Gaffin. John Morgan, Terressa Clark, Daniel Gaffin, Katie Sims, and Sara Hart voted in favor of the motion, none opposed.

2. Request for Consideration of Residential Housing Code Violations at 954 East Lowell Avenue, (Case No. HAZ2023-00482 Yingying Zhang), Council District 4 – Analia Valdemoros

Appeal deficiency: Window opening in basement windows. Current opening is 13.5" W x 15" H. Full space opening is 36"x 20".

Motion by Daniel Gaffin to deny the appeal of deficient egress window size 13.5" W x 15" H opening and recommended installing a casement window and ladder to meet sill height. Second by Katie Sims. John Morgan, Terressa Clark, Daniel Gaffin, Katie Sims, and Sara Hart voted in favor of the motion, none opposed.
