**OAM2023-000994** – (**Continued from October 19, 2023**) An ordinance amending the following sections of the Salt Lake County Code of Ordinances, 2001: 19.12.020 (permitted uses in the FR zone), 19.12.030(g) (conditional uses in the FR zone), and 19.54.020 (permitted uses in the FA zone) to have distinct regulations in the FR and FA zones with regards to animal uses and their associated impacts on adjoining properties, the environment, and the well-being of animals; and making other related changes. **Presenter:** Brian Tucker and Zach Shaw (Motion/Voting)

*Greater Salt Lake Municipal Services District Planning Manager Brian Tucker provided an analysis of the ordinance amendment.* 

Commissioners and staff had a brief discussion regarding who this ordinance amendment comes before for consideration and approval and about the requirement for masonry or durable walls for fencing as recommended by the mayor.

Commissioner Cohen motioned to open the public hearing, Commissioner Vance seconded that motion.

## PUBLIC HEARING OPENED

Speaker # 1: Citizen Name: Katie Jelitto Address: 15152 South Rose Canyon Road

**Comments:** Ms. Jelitto said the example given by staff was a forty-acre parcel subdivided, which seemed like a major subdivision. She asked why they would want to push through this type of subdivision without review. She also asked about what a solid visual fence means.

Mr. Tucker said a forty-acre lot would be a major subdivision and go through phases. Noticing would be required at that time and the review process would be followed. Mr. Tucker read from 18.14.160B, regarding a solid visual fence. The proposed language doesn't say you have to have a masonry wall, just a solid visual barrier that is six feet tall.

Commissioner Cohen motioned to close the public hearing, Commissioner Vance seconded that motion.
