PHILLIP HART- AFTER BEING SWORN IN ALSO ATTENDING WAS MR. HART'S WIFE VICKIE HART BOTH WERE SWORN IN, AGENT VANDERBEEK READ THE DISPOSITION. ON JUNE 14TH 2023, MR HART'S UTAH CONCEALED FIREARM PERMIT WAS DENIED BASED ON A DECEMBER 18TH, 1990 FELONY CONVICTION OF AGGRAVATED ASSAULT AND MULTIPLE OTHER FELONIES THROUGH THE STATE OF ARIZONA. MR. HART SHARED DOCUMENTS WITH THE BOARD, AGENT VANDERBEEK ADDED THE PAPERWORK TO HIS FILE, THE BOARD AGREED THAT THEIR HANDS WERE TIED BECAUSE OF THE SEX OFFENDER REGISTRATION LIST THROUGH THE STATE OF AZ, AGENT VANDERBEEK STATED THAT HE WOULD NEED TO START WITH BCI AND GO THROUGH THE EXPUNGEMENT PROCESS AND WORK WITH THE STATE OF AZ TO HAVE THE CHARGES EXPUNGED. THEN TO CALL AND KEEP AGENT COLBY VANDERBEEK INFORMED SO WE CAN UPDATE OR FILES WITH THE CURRENT RECORDS. ADAM MOTIONS TO UPHOLD THE DENIAL, JEREMY SECONDS THE MOTION ALL IN FAVOR TO UPHOLD THE DENIAL THROUGH THE STATE OF UTAH.

ROSS GRENKO-AFTER BEING SWORN IN AGENT HESLOP READ THE DISPOSITION, ON AUGUST 30TH 2023, MR. GRENKO'S UTAH CONCEALED FIREARM PERMIT WAS REVOKED BASED ON AN AUGUST 21ST, CONVICTION FOR IMPAIRED DRIVING IN THE STATE OF UTAH.MR.
