NOTICE IS HEREBY GIVEN Pursuant to Utah Code Title 10, Chapter 9a, Section 205, that the Kearns Metro Township Planning Commission (the “Commission”) will hold a public hearing on Wednesday, January 3, 2024, beginning at 5:30 PM (Meeting location on the back page). The purpose of the hearing is to receive public comments regarding:

- **OAM2023-001019** – Planning Staff is requesting an ordinance amendment to Table 19.32.030 to remove Self-Service Storage Facilities from the allowed uses list in the Commercial Zones. **Location:** Kearns Metro Township. **Planner:** Jeff Miller

Prior to opening the public hearing, the Planning Commission will hear a presentation from planning staff regarding the ordinance amendment. This item affects all commercial areas within Kearns Metro Township.
