Roll Call

Approval of Bluff Town Council Regular Meeting Minutes of December 12, 2023 Sayers motioned to approve the minutes, Hook seconded and Leppanen, Hook, Sosa and Sayers voted in favor, Murray abstained

Approval of Bluff Town Council and Utah Dine Bikeyah Meeting to Walk Through the Cooperative Cultural Center for Discussion on Demolition

Sayers motioned to approve the minutes, Murray seconded and Leppanen, Hook, Murray, Sosa and Sayers voted in favor

Public Comment:

Kathy Smith voiced her concerns about a multi-use path going along the edge of Allan's property because it is a residential area and could make their property subject to theft and poor behavior. In general, she has seen and supports tourists going down the public road and trails connecting communities. Leppanen thanked her for her comments.

Unfinished Business

1. Update on Bears Ears Partnership (BEP) Work with the Town of Bluff (Leppanen)

Leppanen explained Sarah Burak raised the question of collaborating with the Council over the Dark Skies Initiative and Leppanen met with Joe Neuhof and Burak about

creating a Memorandum Of Understanding between the two entities. BEP has been involved in education and measurement. Leppanen will continue to explore this and check with the Town Attorney. Murray applauded the idea of the joint involvement.

2. Update on AmeriCorps Red 4 NCCC Team and Work to Be Done; Vote on changes to housing costs; Cleaning Supplies and Food Needs for First Night in Bluff (Leppanen/Nelson)

Leppanen updated that the team of 8 to 9 will arrive January 8th for 44 days and asked the community and Council for contributions of food for their first night. They will stay at St. Christopher's and go food shopping the next day when they have orientation and go to Blanding for a tour of Edge of the Cedars and lunch. There are cleaning supplies left over from the eclipse. Dine Bikeyah has not yet committed to sharing the \$6,000 housing cost and Leppanen asked the Council about covering the whole thing if needed. The Council agreed the work they do is a big benefit to the town. Murray motioned to fully cover the \$6,000 if needed, Sayers seconded and Leppanen, Sosa, Hook, Murray and Sayers voted in favor.

3. Report on Meeting with Utah Dine Bikeyah (UDB) at the Cooperative Cultural Center (CCC) on December 15, 2023 (All) and the meeting with Design Review Committee (DRC) on Tuesday, December 19, 2023 (Sayers)

Leppanen, Nelson, Sosa, Hook, Sayers, Jen Davila and Britt Hornsby were joined by Janet Slowman-Chee, Melanie Daniels, Dave Conine, and Damian Bollermann at the Cooperative Cultural Center at 9:00 a.m. to go through the building and discuss work the AmeriCorps team could do. Slowman-Chee and Daniels left shortly after for a board meeting and the remaining group decided on removing carpeting and baseboards, continuing ceiling removal, and taking down whiteboards and storing. Sayers and Daniels will supervise some of the work at the CCC. Leppanen mentioned the need for agreement from the Dine Bikeyah Board. Sayers reported a short DRC meeting that clarified a few things.

4. Summary of Meeting on December 11, 2023 and Update on Bluff Airport and Need for Approval of Capital Improvement Projects for the Airport (Jim Hook, Manager/Nelson)

Jim Hook reported he met with an airport engineer about a 5 to 10-year plan for airport maintenance and improvement, a several million-dollar project. He monitors a website that offers grant funding. Leppanen suggested waiting until the new officials are seated and will look into capital improvements. There is no deadline for this.

5. Report on Planning and Zoning Meetings and Planning and Zoning's Presentation of the Work on the Sign Ordinance Revisions to the Business Owners of Bluff on December 12, 2023 (Hook/Leppanen)

Hook reported Amanda Podmore presented the sign ordinance that Planning and Zoning is working on. There will be a public hearing for the public to express there concerns and ideas. The Commission is working on RV and dirt moving ordinances.

Moab has dirt moving ordinances that are based on geographic and public hazards. They have chosen the Michael Hanson group for work on subdivisions.

New Business

6. Report on Utah League of Cities and Towns "Elected Officials Essentials" Training on December 16, 2023 (Leppanen/Sosa)

Leppanen and Sosa watched this virtual training with Jen Davila and Britt Hornsby. Leppanen noted the salient points covered in the four-hour training were ethics, land use and conflicts of interest. Todd Godfrey, attorney for ULCT, encouraged stepping back from discussions and vote with a conflict of interest, especially if a council member has a business conflict or could gain financially. A great deal of information was covered and a new handbook was given to participants.

7. Discussion and Vote on Year-End Bonuses for Employees (Leppanen/Sosa) Murray motioned to again give \$50 bonuses to employees and Planning and Zoning Commissioners, Sayers seconded and Leppanen, Hook, Murray, Sosa and Sayers voted in favor.

8. Report on LHCC Meeting on December 18, 2023 (Leppanen)

Leppanen attended the quarterly Local Homeless Coordinating Committee and reported Mack McDonald gave background on what the group has done the last several years. This is federally mandated and grant funds are available to people in need. The Mission has received some of this funding. The Point in Time Count is three days starting about January 26th and Leppanen would like help doing the count, this is important to people in need. Sayers would like to see a fact sheet of what the County has done. Murray motioned that Leppanen ask for a fact sheet at the next meeting, Sayers seconded and Leppanen, Hook, Murray, Sosa and Sayers voted in favor

9. Update on Short Term Rental and Business Licenses (Sosa)

Sosa reported all renewal letters have gone out and the business licenses are now \$25. Many have already responded with their fee. Hook asked for a print out of the short-term rentals and businesses.

10. Financial Report (Sosa)

Murray motioned to approve the bills, Sayers seconded and Leppanen, Murray, Sosa, Hook, and Murray voted in favor.
